THE KERALA CIVIL COURTS (AMENDMENT) BILL, 2012

(Report of the Subject Committee)

Subject Committee XIV—Home Affairs to which the Kerala Civil Courts (Amendment) Bill, 2012 (Bill No. 90) was referred, considered the Bill clause by clause and now submits this report with the Bill as reported by the Committee annexed thereto.

2. The Kerala Civil Courts (Amendment) Bill, 2012 was published as a Gazette Extraordinary dated May 8, 2012. The Bill was introduced in the Assembly on April 2, 2013 and was referred to the Committee on the same day.

3. The Committee considered the Bill clause by clause at its meeting held on April 2, 2013 and the Committee recommends to adopt the Bill with the following modification, namely:—

- (i) In the Enacting formula for the word "Sixty-third" the word "Sixty-fourth" shall be substituted.
- (ii) In clause 1(1) for the figure "2012" the figure "2013" shall be substituted.
- 4. The minutes of dissent is appended.

further to amend the Kerala Civil Courts Act, 1957.

Preamble.—WHEREAS, it is expedient further to amend the Kerala Civil Courts Act, 1957 for the purposes hereinafter appearing ;

BE it enacted in the Sixty-fourth Year of the Republic of India as follows:-

1. *Short title and commencement.*—(1) This Act may be called the Kerala Civil Courts (Amendment) Act, <u>2013.</u>

(2) It shall come into force at once.

2. Amendment of section 11.—In sub-section (2) of section 11 of the Kerala Civil Courts Act, 1957 (1 of 1957) (hereinafter referred to as the principal Act), for the words "one lakh rupees", the words "seven lakh and fifty thousand rupees" shall be substituted.

3. Amendment of section 13.—In sub-section (1) of section 13 of the principal Act, for the words "two lakh rupees", the words "twenty lakh rupees" shall be substituted.
