# THE PAYMENT OF SALARIES AND ALLOWANCES (THIRD AMENDMENT) BILL, 2012

(Report of the Subject Committee)

Subject Committee XIV—Home Affairs to which the Payment of Salaries and Allowances (Third Amendment) Bill, 2012 (Bill No. 156) was referred, considered the Bill clause by clause and now submits this report with the Bill as reported by the Committee annexed thereto.

- 2. The Payment of Salaries and Allowances (Third Amendment) Bill, 2012 was published as a Gazette Extraordinary dated November 28, 2012. The Bill was introduced in the Assembly on February 11, 2013 and was referred to the Committee on the same day.
- 3. The Committee considered the Bill clause by clause at its meeting held on February 14, 2013 and the Committee recommends to adopt the Bill with the following modifications, namely:—
- (i) In the enacting formula for the words "Sixty-third", the words "Sixty-fourth" shall be substituted.
- (ii) For sub-clause (1) of Clause 1 of the Bill, the following shall be substituted:
- "1. <u>Short title and commencement</u>.—(1) This Act may be called the Payment of Salaries and Allowances (Amendment) Act, 2013.".

# THE PAYMENT OF SALARIES AND ALLOWANCES (THIRD AMENDMENT) BILL, 2012

(As reported by the Subject Committee)

#### BILL

further to amend the Payment of Salaries and Allowances Act, 1951.

*Preamble.*—Whereas, it is expedient further to amend the Payment of Salaries and Allowances Act, 1951 for the purpose hereinafter appearing;

BE it enacted in the Sixty-fourth Year of the Republic of India as follows:—

- 1. Short title and commencement.—(1) This Act may be called the Payment of Salaries and Allowances (Amendment) Act, 2013.
  - (2) It shall come into force at once.
- 2. *Insertion of new Section 8C.*—After Section 8B of the Payment of Salaries and Allowances Act, 1951 (XIV of 1951), the following Section shall be inserted, namely:—
- "8C. Reimbursement of amount incurred in connection with purchase of books.—Subject to such rules as may be made in this behalf, every member of the Legislative Assembly including the Speaker, the Deputy Speaker, the Leader of Opposition, the Chief Whip and the Ministers shall be entitled to get the expenditure incurred in connection with purchase of books reimbursed subject to a maximum of rupees fifteen thousand every financial year."
