

### ORDER

Safety policy of KSEB Ltd and safe work procedure for Distribution and Transmission wing was prepared by the committee formed vide order read as 1 above and was submitted for approval before Full Time Directors of KSEB Ltd. The meeting of Full Time Directors of KSEB Ltd held on 15.11.2018 decided to entrust the Director (D& IT) for thorough review of the documents and to make necessary corrections before issuing approval.

The Director (D&IT) has submitted the remarks and suggested to constitute an independent committee to study the document in detail and to make appropriate corrective interventions on the matter. A committee headed by the Chief safety commissioner was formed for thorough checking of the document as per order read as 2 above. The committee include experts from distribution wing as members and thorough checking and restructuring of safety procedure was done by the committee. The comments raised from the office of the Director (D&IT) were addressed properly and the document was modified by giving due importance for reducing interruptions without diluting the safety aspects to be followed in each type of works.

Revised safety policy and safe work procedure for Distribution and Transmission wing was submitted for review and approval vide note read 3 above. Safe work procedure for distribution and transmission wing were prepared as two volumes and it was proposed to provide hard copy and soft copy of the document in all offices concerned to enlighten the field staff and to implement a new safety culture in KSEB Ltd. The final proof reading and thorough checking of the document was proposed to be carried out by the members of the committee formed for the preparation of safety procedure vide order read as 1 above. Also, it was proposed to conduct training to officers in district level and the trained officers shall conduct classes in section level all over the state to make the field staff aware about the safe work practices in their field of work.

Having considered the recommendations of Chief Safety Commissioner in the note read above, the Full Time Directors meeting held on 04.04.2019 resolved to approve the revised safety policy of KSEB Ltd and safe work procedure for Distribution and Transmission wing submitted in two volumes. The meeting further resolved to direct the Chief Safety Commissioner to work out the realistic minimum number of copies to be printed and resubmit the details.

Orders are issued accordingly.



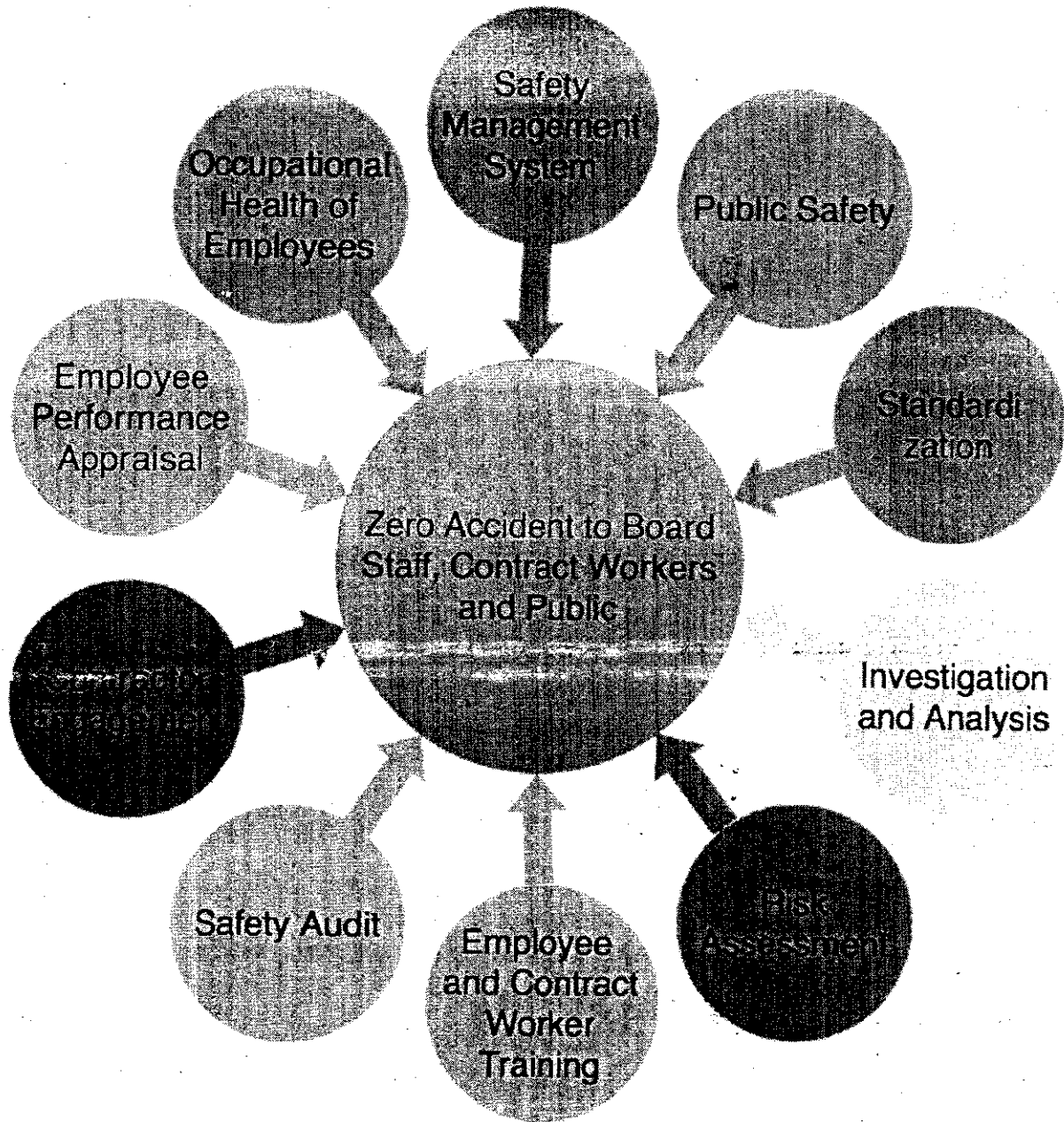

Safety Policy of KSEB Ltd



## Safety Policy

KSEB Ltd is undertaking Generation, Transmission and Distribution of electricity all over Kerala. KSEB Ltd shall strive for excellence in safety and to become a global leader in best practices in safety and is committed to:


1. Ensure zero accident to its employees, contractors and general public.
2. Prevention of injury and ill health at the workplace for employees and contractors.
3. Prevention of accidents from its installations and ensuring safe usage of electricity by general public.
4. Continual improvement of overall health, safety and environmental performance.

Every individual working for and on behalf of KSEB Ltd shares the responsibility towards achieving these commitments. KSEB Ltd shall meet its commitments through the following :

- **Management System:** A safety management system, based on the requirements of the prevailing CEA Safety Regulations, relevant standards including IS 5216 and OHSAS 18001:2007 Occupational Health & Safety Management System and other applicable regulations will be implemented and maintained. It shall be ensured that operations will be conducted as per the applicable legal requirements and other requirements to which KSEB Ltd has committed.
- **Risk Assessment:** KSEB Ltd will identify hazards related to supply and usage of electricity and minimize risks that could cause injury, ill health or significant environmental impacts. It is the duty of each employee to report immediately to their Supervisor any hazardous condition, injury, ill health or accident related to the workplace.
- **Standardization:** KSEB Ltd is committed to
  - Comply mandatory safety standards specified by Central Electricity Authority and other statutory bodies.
  - Establish, monitor and communicate to employees, realistic and measurable goals for improving safety standards.
  - Formulate, update and implement standard safe work procedure based on relevant standards.
- **Employee and Contract Worker Training:** KSEB Ltd shall provide appropriate training, adequate tools, safety gadgets and support to complete their tasks safely and to follow safe

work practices to protect themselves, their fellow workers, the general public and environment.

- **Safety Audit:** KSEB Ltd shall enforce a system of safety audit to ensure compliance of safety practices.
- **Employee Performance Appraisal:** Adherence to safety practices and safe work procedures shall be considered as one of the criteria in the performance appraisal report of employees.
- **Occupational Health of Employees:** Occupational health of employees shall be given top priority and periodic health checkup of employees shall be conducted.
- **Contractor Engagement:** KSEB Ltd shall ensure that all its contractors meet all qualifying criteria as per CEA Regulations and be competent to complete the work assigned to them safely. KSEB Ltd shall make all the Contractors aware of their responsibilities related to the safety management system.
- **Investigation and analysis:** Incident & accident investigation and analysis shall be conducted to avoid the recurrence of similar nature. Input from the grass root levels of the organization shall be encouraged to improve the effectiveness of the safety management system.
- **Public Safety:** KSEB Ltd will provide the general public with awareness on potential risks associated with its operations. KSEB Ltd will ensure that all the installations meet the relevant standards for safe usage of electricity.
