Subject: Revision of fares, 1984 - issue of  
Concession tickets - regarding.

The Government have issued directions to revise fares of all state owned services in the State. The order will come into force from 30.03.84 on 31.03.1984. Consequently the following instructions are issued to all Unit Officers regarding issue of concession tickets to regular and parallel students.

(1) Full time regular students not engaged in any other calling or profession studying in any recognised educational institutions for a recognised course travelling in stage carriage for a distance not exceeding 40 kms. for a single journey for the purpose of attending classes, shall be eligible for concession at the rate of 75% of the revised fare for travelling in City/Town/Ordinary/Offussil services.

(2) Full time students not engaged in any other calling or profession studying privately in any Institutions and who has registered his/her name in any of the Universities in Kerala as a student for a particular course or private study admitted by University travelling in stage carriages for a distance not exceeding 40 kms. for a single journey for the purpose of attending classes shall be eligible for concession at the rate of 50% of the revised fare for travel in City/Town and Ordinary/Offussil services.

(3) Concession tickets will be issued for full time students attending recognised courses in recognised educational institutions. The recognised educational institutions means:

- (a) Industrial Training Centres in the public and private sector affiliated to the National Council for Training in Vocational Fields and Recognised by the Director of Technical Education.
- (b) High School, Primary School and Special Schools and Training Schools and other recognised Educational Institutions under the control of the Department of Education.
- (c) College affiliated to the Universities;
- (d) Technical Institutions recognised by the Director of Technical Education;
- (e) Educational Institutions recognised by the Government of India and
- (f) Educational Institutions directly run by the Government or owned by the Government of India.

Recognised course means:

Full time courses recognised by the Department of Education, Director of Technical Education, Director of Medical Education and Universities conducted in "Recognised Educational Institution".

(4) Concession ticket will be issued for the period of 10 months from the date of commencement of the recognised courses. Except in the case of students who are attending schools concession ticket will be issued only after getting course certificate from the institutions to ascertain the date of commencement of the course and issue of concession ticket should be limited for a period of 10 months from the date of commencement of the course.

(5) Concession ticket for Regular students will be issued for a period of 10 months for the first five denominations. And for the other denominations the 3 months' concession ticket will be issued. The cost of 10 months concession card will be Rs. 2/- (Rupees Two only) and that for three months' concession card will be Rs. 1/- (Rupee One only).

(6) Concession ticket for 3 months' to parallel college students will be issued subject to the following conditions also.

(a) For first year students on production of Registration Certificate issued by the Universities in Kerala.

(b) for second year and third year students on production of hall tickets issued for the previous examination (1st or 2nd year as the case may be) of any of the Universities in Kerala along with identity cards issued to eligible students on production of those affixed in identity cards attested by a gazetted officer or Principal of Colleges affiliated to any of the Universities in Kerala and subject to the effect that he/she has registered his/her name in any of the Universities in Kerala.

(c) for renewal of concession ticket counter signature of a Gazetted Officer should be obtained in the concession card in addition to the attestation made by the Principal.

(7) At the time of issue of concession ticket during the end of the course if it is not possible to issue concession ticket covering a period of 3 months, a written undertaking from the student should be obtained to the effect that the student has no objections to remit the full charges for three months' concession ticket even though the period of validity is less than three months, for issue of concession ticket for any period less than 3 months after realising full fare for the period of 3 months.

(8) In the case of nationalised sectors where there are two or more services concession tickets will be issued without limiting the number of concession tickets. In the case of non-nationalised sectors where KERNCO is operating more than one service the number of concession tickets will be restricted to 25 per student in non-nationalised sectors where there is a service.

skeleton services, no concession tickets should be issued. No fresh concession tickets will be issued in non-nationalised areas where concession tickets have not been issued so far. Also when new services are introduced concession tickets should not be issued for travel in that services for one year and for issue of concession after that period sanction should be obtained from Chief Office.

(9) Concession tickets need not be issued to the students of those institutions where the students of the institution damage KARTC vehicles/properties. Specific sanction has to be obtained from Chief Office for the issue/renewal of concession tickets to such institutions after realising the cost of damage.

(10) Whenever concession tickets are withdrawn in fraudulent cases by the Inspectors, Depot staff, Concession ticket will not be issued to that student during that academic year. The matter should also be reported to the respective institution with a copy to Traffic Section, Chief Office.

(11) In the case of lost tickets, a penalty equivalent to the value of 210 single journeys of the full fare have to be realised and concession ticket should be issued only after the expiry of the period of validity of the previous concession ticket. In the case of 10 months' concession card lost, no concession tickets will be issued for the student during that academic year.

(12) Strict instructions should be given to operating crew not to entertain concession tickets on Sunday and on other public holidays including those holidays declared by Government, District Collector or any other Authorities from time to time.

(13) Concession tickets should not be issued for those students who are in receipt of stipend except for those students who are attending ITI/TTC courses. In the case of Scheduled Caste/Scheduled Tribe students concession tickets can be issued even if they are in receipt of stipend.

(14) Concession tickets will not be issued for those students who are attending different types of training after completion of course.

(15) Concession tickets can be issued during the middle of a course only on production of a certificate on change of residence from the Panchayat/Municipality certificate and also from the head of the institution. In such cases issue of concession tickets should be limited for a period of 12 months from the date of commencement of the course for which the student is now undertaking. A proper enquiry should be conducted at that level if necessary before issue of such concession tickets.

Concession tickets for the students' examinations are available in Stationery shops. The concerned staff/officers are directed to place orders for the same immediately.

Revised fare for different denominations are enclosed for ready reference. In the case of concession tickets already issued for the period beyond 31.3.1994 the difference of fare should be realised w.e.f. 1.4.1994 after issuing receipts for the balance payment. In such cases receipt No. and date should be entered in the concession ticket under the head and seal of Unit Officer.

Unit Officers concerned will inform in writing the Institution heads to direct the concession ticket holders to remit the difference in the concessional fare before 15.4.1994.

The operating crew and the supervisory staff should not entertain the concession ticket holders who have not remitted the difference in concessional fare before 15.4.1994.
