KOCHI LINES package included in TransGrid 2.0 project were tendered vide eTender No. DCE/TransGrid (S)/03/2017-18 dt. 18.11.17. The evaluation of these tenders were done and submitted for approval. The proposal was discussed in the 37th Meeting of the Board of Directors held on 20.01.2018 vide agenda 15-01/2018.

M/s KIIFB has accorded sanction for funding Kochi Lines Package coming under TransGrid 2.0 project vide Order no. APR-1/76/2017/KIIFB dated 3/6/2017 of M/s KIIFB for an amount of Rs.372. 72 Cr and balance Rs.6.73Cr sanctioned as centage charges. TS for the Kochi Lines Package was issued by the CE level Committee headed by Chief Engineer (TSO), Kalamassery vide TS No.01/17-18 dt.06/07/17 for Rs.379.45 crores. The line work has been tendered among the prequalified bidders short listed as per EoI and out of the six empanelled bidders ,three bidders participated in the bid. The bids were submitted to the Financial Adviser for remarks and based on his remarks, negotiations were conducted with L1, M/s L&T Ltd., Chennai.

Accordingly, the proposal was put forth before Bid Evaluation and Greviance Redressal Committee and the committee recommended for awarding the above work to M/s L&T Ltd., Chennai at the negotiated total amount of Rs. 251,09,80,296/-. Since the rates are excluding GST, the applicable GST on material & labour will be extra as per actual. The Committee also recommends disposing the dismantled materials to M/s. L&T Ltd. at the revised rate of Rs. 10,07,10,500/- agreed by them.

The FTD meeting held on 10.01.2018 discussed the proposal in detail and decided to recommend the matter before the Full Board for approval.

The Board of Directors held on 20.01.2018 have examined the proposal in detail and considering the fact that ,TransGrid projects are time bound, it was resolved to accord sanction:

- To award the "Kochi Lines Package" to the L1 bidder, M/s L&T Ltd., Chennai at their quoted rate of Rs. 251,09,80,296/-(Rupees Two hundred and fifty one crore Nine lakhs Eighty thousand Two hundred and Ninety Six only) at 40 % tender excess.(taxes extra)
- 2. To sell the dismantled materials to M/s L&T Ltd., Chennal for an amount of Rs. 10,07,10,500/- (Rupees Ten Crore seven Lakhs Ten thousand and Five Hundred Only)

GIS package-1(Construction of 220 kV GIS at Aluva, Kaloor and Kunnamangalam including 2 nos. 220 kV bays at Brahmapuram Substation on Turnkey Basis) included in TransGrid 2.0 project were tendered vide ReeTender No. DCE/ TransGrid (S)/08/2017-18 dt. 27.02.18. The evaluation of these tenders were done and submitted for approval. The proposal was discussed in the 40th Meeting of the Board of Directors held on 20.06.2018 vide agenda(29-6/2018).

Technical Sanction for the package was issued by the CE level Committee headed by Chief Engineer (TSO), Kalamassery vide TS No.08/17-18 dt.03/02/18 for Rs.229.40 crores of the Deputy Chief Engineer (TransGrid South). The substation work has been tendered among the prequalified bidders short listed as per Eol and out of the five empanelled bidders , four bidders participated in the bid. The bid submitted by M/s ABB Ltd has been rejected due to some defects found in the preliminary evaluation of the tender. The bids submitted by others were evaluated by the internal technical committee and the committee decided to prequalify the following bidders based on the bids submitted.

- 1) M/s GE T&D India Limited,
- 2) M/s Siemens Ltd. and
- 3) M/s Larsen & Tubro Ltd.

The price bids of the above bidders were opened and it was found that M/s Siemens Ltd has quoted the lowest. As per the tender conditions the tender is to be evaluated based on the loss capitalization on 220kV transformers and thus after transformer loss capitalization, the offer of M/s GT T&D India Ltd. became the lowest. The bids were submitted to the Financial Adviser for remarks and based on his remarks, negotiations were conducted with L1 bidder M/s GE T&D India Ltd. as their quoted price for Consumable Spares and T & P is found to be 115% above estimate. Hence Deputy Chief Engineer(TransGrid South) requested to offer rock bottom rate to the L1 bidder and they have offered to reduce the quote for Consumable Spares & Tools (BoQ4) by 1%. Hence the modified quote comes to Rs. 136,98,65,939.79/- (29.48% below estimate).

Accordingly, the proposal was put forth before Bid Evaluation and Greviance Redressal Committee held on 07.06.2018 and the committee analyzed the bids and made the following recommendations

- (1) Purchase of spares may be limited to those not covered under guarantee and those being kept handy would significantly reduce the possible downtime without much cost.
- (2) As 'TELK' is the only manufacturer mentioned specifically and their loss values are quoted, in the GTP for Transformers, submitted by M/s GE, supply of TELK-make transformers should be insisted. It is legally in the rights of the purchaser to insist on exactly what is offered in an accepted bid. A letter shall be sent to M/s GE asking to supply TELK-make transformer if contract is awarded to them, and also making clear that their response of keeping their options open regarding the make of the transformers to be supplied is not legally sustainable and has to be rejected.
- (3) The bid price arrived at is reasonable and the approval for the bid at the lowest price of M/s GE T&D Limited may be sought from the Board.
- (4) An in-principle investment approval may be sought from Hon'ble KSERC for this package.

On review of all the above facts and figures, the Bid Evaluation & Grievance Redressal Committee (BE &GR Committee) unanimously recommended for awarding the above work to M/s GE T&D Limited, Chennai at the negotiated total amount of Rs 136,98,65,939.79/- (29.48% below estimate) without GST after getting approval of the Board and also considering the fact that they will supply only TELK make 220kV transformers for this project during execution, as offered in their bid.

The FTD meeting held on 12.06.2018 discussed the proposal in detail and decided to recommend the matter before the Full Board for approval.

The Board of Directors held on 20.06.2018 have examined the proposal in detail and ,it was resolved to accord sanction to admit M/s GE T&D India Limited, Chennai as L1 bidder for execution of GIS

Package-1(Construction of 220 kV GIS at Aluva, Kaloor and Kunnamangalam including 2 nos. 220 kV bays at Brahmapuram Substation on Turnkey Basis) and to award the work of GIS Package-1 to M/s GE T&D India Limited, Chennai at their rock bottom rate of Rs 136,98,65,939.79/- (29.48% below estimate) on the condition that they will supply only TELK make 220kV transformers for this project during execution, as offered in their bid.

The substation work has been tendered among the prequalified bidders short listed as per EoI and out of the five empanelled bidders, three bidders participated in the bid.

The price bids of the above bidders were opened and it was found that M/s Siemens Ltd has quoted the lowest with quoted amount of Rs.137,98,58,314/-(Rupees One Hundred and Thirty Seven crores Ninety Eight lakhs Fifty Eight thousand Three hundred and Fourteen only). Based on the T.S amount of Rs.131,42,97,206/- the overall excess over the estimate is only 4.988%. The excess amount above the sanctioned estimate is Rs.6,55,61,108/-.

The bids were submitted to the Financial Adviser for remarks and based on his remarks and the recommendations of BE &GR committee meeting held on 07.06.2018, negotiations were conducted

with L1 bidder M/s. Siemens Ltd and they have offered a discount of Rs 1,50,000/- on the overall bid price. Hence the modified quote comes to Rs. 137,97,08,313.58/- (4.976 % above estimate).

The Bid Evaluation & Grievance Redresssal Committee (BE &GR Committee) recommended for awarding the above work to M/s Siemens Ltd after getting approval of the Board.

The FTD meeting held on 12.06.2018 discussed the proposal in detail and decided to recommend the matter before the Full Board for approval.

The Board of Directors held on 20.06.2018 have examined the proposal in detail and ,it was resolved to award the work of AIS Substation Package#1 to M/s Siemens Ltd., Gurgaon for an amount of Rs. 137,97,08,313/-(Rupees One hundred and thirty seven crores ninety seven lakhs eight thousand three hundred and thirteen only) which is 4.976 % above estimated PAC.

Administrative sanction was accorded for the construction of approx. 4.5kM of 220kV Double Circuit line from 220kV Substation Brahmapuram to Thuthiyoor termination station and laying of approx. 6 kM of 220kV Double Circuit Under Ground Cable from Thuthiyoor to Kaloor substation vide B.O No.3160/2015/D(T&SO)/T2/220kV Kaloor/Upgdn/2015) dated 18-12-2015 above as part of Kochi Lines Package in TransGrid 2.0. As there is only limited quantity of EHV cable laying in Transgrid 2.0 project, vendors related to cables and accessories were not empanelled in EOI for lines. Hence sanction was given vide Lr.No.D(T&SO)/PSE/TransGrid (S)/Kaloor Upgdn/2017-18/87 dated 8-06-2017 to invite open tender for the cable laying work with similar pregualification conditions prescribed in EOI for lines.

The CE level technical committee constituted for TransGrid (South) finalised the working estimate and technical specifications of 220kV Double Circuit UG cable from Thuthiyoor to Kaloor substation and accorded sanction for the working estimate amounting to Rs. 59.5 Crore for the subject work. Accordingly, open tenders were invited for the execution of Kochi lines cable package from the office of the Deputy Chief Engineer with full powers of CE (Trans Grid South) with the similar prequalification conditions to that EOI for transmission lines. Three bidders viz. M/s. KEI Industries Ltd., New Delhi, M/s. Universal Cables Ltd., Satna and M/s. Fin clex J- Power Systems Pvt. Ltd., Pune participated in the tender and submitted their offers. On evaluation of the bids, it was found that out of the three bidders, only one bidder (M/s. KEI Industries Ltd.) satisfied all PreQ conditions.

The BE & GR committee meeting held on 20-02-2018 observed that the poor participation of tenderers was due to the stringent technical and financial conditions laid down in the tender. Hence the committee decided to cancel the tender and to retender the same after modifying the financial conditions to get more

participation and suggested that the technical conditions need not be modified since it may adversely affect the quality of work.

The work was retendered with the revised qualifying requirements as per B.O (DB) No.1223/2018/D(T&SO)/PSE/TransGrid/Kochi Lines (Cable)/18-19 dated Thiruvananthapuram 09-05-2018. Two bidders M/s. KEI Industries Ltd., New Delhi and M/s. Universal Cables Ltd., Satna were participated and on evaluation of the bids by the technical committee, both of the bids have been found satisfying the technical as well as financial criteria laid down in the tender and were prequalified. The price bids of the above bidders were opened and it was found that M/s KEI Industries Ltd., New Delhi has quoted the lowest with the quoted amount of Rs.52,62,92,276/-(Rupees Fifty Two Crores Sixty Two Lakhs Ninety Two Thousand Two Hundred and Seventy Six only) excluding GST.

The bids were submitted to the Financial Adviser and based on his remarks, negotiations were conducted with the lowest bidder, M/s KEI Ltd., New Delhi and they have offered a reduction of 0.5% on their overall bid price. The modified amount comes to Rs. 52, 13, 06,541/-(7.5% above estimate). The Bid Evaluation & Grievance Redressal committee (BE&GR committer) recommended to award the work to the L₁ bidder after obtaining sanction from the Board.

The FTD meeting held on 19-06-2018 discussed the proposal and decided to place the matter before the Full Board. The Board of Directors held on 20-06-2018, have examined the proposal in detail and resolved to accord sanction to award the work of Kochi Lines Cable Package to M/s KEI Ltd., New Delhi for an amount of Rs. 52, 13, 06,541/-(Rupees Fifty Two Crores and Thirteen lakhs and six thousand five hundred and forty one only) without GST, which is 7.5% above the estimated PAC.

Orders are issued accordingly.

As part of TransGrid project, Administrative Sanction was accorded vide B.O read 1 above, for the construction / up-gradation of 220/110kV lines using Narrow base Multi Circuit Multi Voltage (MCMV) Towers, from Kanhirode to Mylatti under Kolathunad Line Strengthening Package (KLSP) (vide B.O. dtd 20.11.2017) and for North malabar Line Package (NMLP) vide B.O read 2 above, in two phases: Project A: Construction of 22.236 km 220/110 kV MCMV line from Mundayad to Thalassery & Project B: Conversion of 7.66 km of 110 kV DC line to 220kV / 110kV Multi circuit from Areacode — Kaniyambetta tap point to Kunnamangalam Substation through Existing Agasthiarmuzhi 110 kV line route.

The tendering of the 2 projects as a single package was entrusted to M/s. RECTPCL as Bid Process Coordinator (BPC) vide BO read 3 above. Accordingly, M/s.RECTPCL has invited open e-tenders with e- Reverse auction. Only three firms participated in the bidding and after prequalification and e-reverse auction, M/s. Sterlite Power Transmission Ltd., became the L1 bidder by quoting an amount of Rs 375,41,44,251/- (including GST). The amount comes to Rs.368,63,99,684/-after deducting the final offer for dismantled materials, which is Rs.6,77,44,567/- including GST. (Rs 5,74,10,650/- excluding GST)

On negotiation at Board level, L1 bidder offered a discount @1.25%, bringing their quoted price down to Rs.372,42,23,633/-(including GST). After deducting the quoted cost of dismantled materials, the final rate will be Rs.365,64,79,066/- only.

The BPC, M/s. RECTPCL recommended to award the work to the lowest bidder M/s. Sterlite Power Transmission Ltd., pointing out that wide variation in quoted price for the labour portion be due to the issues pertaining to hiring of local contractor, Higher Rates of labour, Loading, Unloading & Local Transportation, Existence of Strong Labour Union etc.

BE&GR committee during the meeting held on 12.12.2018 examined the rates offered and suggested to compare the rates with actual market conditions and to place the matter before FTD. Accordingly note was put up to FTD comparing the quoted rate with LMR values, discovered prices etc. and elaborating on the reasons for awarding the work to M/s. Sterlite Power Transmission Ltd. It was directed to place the matter before Director Board for approval.

The matter was placed before the Director Board in the 44th meeting held on 18.2.2019 and it was directed to place the matter with a detailed justification for the excess over the estimated amount with cost index. Accordingly the matter was placed before the Director Board in the 45th meeting held on 22.3.2019 with detailed justification. As part of TransGrid project, Administrative Sanction was accorded vide B.O read as 1 above for the construction / up-gradation of 220/110kV lines using Narrow base MCMV Towers under Kottayam Lines Package (KLP) for establishing connectivity to Ettumanur & Thuravur 220kV substations, North South Interlink Package Phase-I (NSIP) for establishing connectivity to Chalakkudy & Irinjalakkuda 220kV Substations vide B.O read as 2 above and Thrissivaperur Lines Package Phase-I (TLP) for establishing connectivity to Kunnamkulam 220kV Substation, vide B.O read as 3 above.

The tendering of the above 3 projects as a single package, was entrusted to M/s PFC Consulting Ltd. (PFCCL) as Bid Process Coordinator (BPC) vide B.O read as 4 above. Accordingly, M/s PFCCL has invited open e-tenders with e-Reverse auction. Only three firms participated in the bidding and after the prequalification and e-reverse auction, M/s. L & T India Ltd. became the lowest bidder by quoting the lowest amount of Rs 372,52,23,491/- (including GST), after deducting the final offer for dismantled materials, which is Rs.2,94,04,123/- including GST. (ie; Rs.2,49,18,748/- excluding GST)

On negotiation at Board level, L1 bidder offered a discount of Rs. 11,82,23,491/- (inclusive of GST) bringing their quoted price down to Rs.363,64,04,122/-(including GST), which is 72.65% over the estimated rate. After deducting the quoted cost of dismantled materials, the final amount will be Rs.360,70,00,000/- only.

The BPC, M/s.PFCCL recommended to award the work to the lowest bidder M/s.L&T India Ltd., pointing out that wide variation in quoted price for the labour portion may be due to the issues pertaining to hiring of local contractor, Higher Rates of labour, Loading, Unloading & Local Transportation, Existence of Strong Labour Union etc.

Bid Evaluation & Grievance Redressal (BE&GR) Committee during the meeting held on 12.12.2018 examined the rates offered and suggested to compare the rates with actual market conditions and to place the matter before FTD. Accordingly note was put up to FTD comparing the quoted rate with

LMR values, discovered prices etc. and elaborating on the reasons for awarding the work to M/s.L&⁻ It was directed to place the matter before Director Board for approval.

The matter was placed before the Director Board in the 44th meeting held on 18.2.2019 and it was directed to place the matter with a detailed justification for the excess over the estimated amount with cost index. Accordingly the matter was placed before the Director Board in the 45th meeting held on 22.3.2019 with detailed justification and the Board directed that the team headed by the Director(T&SO) shall have a realistic item wise negotiation and thereafter to place the matter before the next Director Board meeting.

Accordingly, detailed item wise negotiation was conducted with the L1 bidder, M/s. L&T and consequently vide letter dtd 6.4.2019, M/s.L&T offered a discount of Rs.24,14,00,000/- on their earlier quote. The quote after discount and considering reduction of price of dismantled materials is Rs.336,56,00,000/-. Thus the revised price for the work after discount (without considering the cost of dismantled materials) comes to Rs.339,50,04,123/-,which is 61.18% above the TS amount. Subsequently, detailed itemwise price schedule was submitted by M/s.L&T, vide letter read 4 above.

The Director (T&SO) reported that re-tender may not result in better quotes, even though the rate quoted by the firm is slightly higher compared to other sanctioned works, which are attributed to the risk factors such as uncertain terrain conditions, increased labour issues, compressed time schedule for completion of project etc. Also, this contract involves construction of 220 kV lines to the proposed 220kV Substation, Chalakudy, which is fast progressing and is scheduled for completion by October 2019. Any delay in completing the Kottayam Lines package will adversely affect the commissioning of the substation and hence has high financial implications. Further, the connecting lines to the substations for which the work has already been tendered - 400kV Substation Kottayam, 220kV Substations Ettumanoor and Kunnamkulam, are also part of the subject project and hence award of the project cannot be delayed. As part of TransGrid 2.0 project, Board vide orders 1& 2 read above accorded Administrative Sanction for the construction of 220 kV GIS Substation and associated works at Ettumanoor and Vizhinjam. The projects are funded by KIIFB.

While KSEBL invited e-tenders with reverse auction, out of 10 qualified bidders (as per the EoI of Substations), six bidders complied with the technical requirements and participated in the tender. For the tendered PAC of Rs. 105,73,29,017/-(excluding GST), M/s.GE T&D India Ltd. was the lowest bidder quoting Rs.99,74,80,024/-. After e-reverse auction M/s. GE T & D India Ltd, reduced the quoted amount to Rs.97,24,80,024/- (excluding GST) which is 8.02% below the PAC.

Based on the recommendation of Chief Engineer (TransGrid) and the BE &GR Committee, the matter was placed before the Full Time Directors. The FTD meeting held on 16.8.2019, directed to place the matter before Director Board. Accordingly, note was placed before the Director Board vide paper read 4 above, recommending that the work may be awarded to M/s GE T&D India

Having considered the matter, the Director Board in the meeting held on 22.08.2019,
