

The Kerala Infrastructure Investment Fund Board (KIIFB) invites short quotation in sealed cover from infrastructure consulting firms for providing and coordinating the required a panel of technical experts and professionals who can assist KIIFB in general technical & financial appraisal of the project reports received for funding and assist in evaluation of the reports. The agency shall abide by the following general responsibility while performing the activity:

1. Act in a fiduciary capacity for KIIFB and other agencies involved within the scope of the work undertaken by it and shall disclose all conflicts of interest as and when they arise.
2. Not receive any consideration by way of remuneration or compensation or in any other form from any person other than KIIFB, in respect of any activity done in relation to the projects for which service is provided.
3. Not divulge any confidential information which has come to its knowledge about KIIFB or public or private entities with which it has to interact pursuant to the commencement of work.
4. Provide independent advice and work under the scope of the assignment, safeguarding the interests of KIIFB to the best of its ability.

The general scope of work is as per Annexure-I. The specific scope of work and project wise activities to be performed and extent of appraisal required, shall be intimated from by KIIFB, by the form of man hours required for / performed by the personals engaged for each activity. The decision of KIIFB in assessing the extent of study required shall be final with respect to any subjective factor in the assessment of quality of the reports submitted by the firm.

The fees corresponding to each project appraisal / advisory activity shall be calculated on the basis of the number projects for which, on completion of the appraisal / advisory thereof, final appraisal / advisory report has been submitted and approved by the Chief Executive Officer, KIIFB.

The firm shall provide a panel of technical experts and professionals in the category of Principal Consultant (with infrastructure industry experience of more than 20 years), Senior Consultant (with experience of more than 15 years) and Consultant Engineers (with experience of more than 8 years) in the corresponding disciplines. The decision of KIIFB shall be final in assessing the number of personnel to be engaged for each project.

The eligibility for quoting will be limited to those firms engaged in infrastructural consultancy sector with capability to provide and arrange the services of professionals as per Annxure-2. The brief Curriculum Vitae of the professionals shall be attached with the offer. At the time of selection bidder shall furnish proof of qualification and the experience claimed in the CV.

The firm shall provide technical experts from various sectors including Bridges and Transportation Infrastructure, Ports and Marine, Waterways, Buildings, Geotechnical & Foundation, Environment, Water Resources & Water Supply Engineering, Electrical

Engineering, Mechanical Engineering Infrastructure, Project Management etc. The technical team shall also be supported with project engineers in corresponding disciplines as required for successful appraisal of the reports and completion of the assignment as per the requirement of KIIFB.

1. Conducting a general scrutiny of the appropriateness of the specific project in the context of infrastructure development needs specific to Kerala scenario.
2. Scrutiny of the requirement / demand analysis and the suitability of the methods adopted specific to the nature of the proposed project
3. Verification of data adopted through site study and from reliable secondary sources
4. Scrutiny of cost benefit analysis adopted in project development
5. Conducting a general technical appraisal of the project documents for its compliance to standards, specifications and requirements of the project proponent and regulators
6. Appraising the financial estimates, cost projection and projected profitability and cash flows
7. Advisory services for cost reduction through review of design aspects and application of value engineering concepts
8. Provide professional consultancy and advisory services for scrutiny of WBS to suit the requirements of the funding agency
9. Support for contract management, funding requirements for timely completion and commissioning of the project in a most effective and economic manner
10. Development of sector wise templates for preparation of project reports for revision of submitted DPR's and for future reports
