**ORDER**

As per the Government Order read above, general guidelines were issued for availing financial resources from Kerala Infrastructure Investment Fund Board (KIIFB). The Chief Engineer, PWD (Roads & Bridges) as per letters read above had submitted a proposal for Administrative Sanction for the improvements of 104 road works by using the funds of Kerala Infrastructure Investment Fund Board (KIIFB) during the current financial year.

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the improvements of 100 road works in the list appended for an amount of ₹ 1815 Crore (Rupees One Thousand Eight Hundred and Fifteen Crore only) under the Special Investment Scheme (anti-recession package) for availing the funds under Kerala Infrastructure Investment Fund Board (KIIFB).

3. The Chief Engineer, PWD (Roads & Bridges) will prepare the DPR for the above works with new technologies and road planning as already envisaged and will be prepared on need based and there should be objectivity and proper application of mind by the field engineers while preparing the DPR.

4. The Kerala Road Fund Board will be the Special Purpose Vehicle (SPV) for executing the works and will submit the DPR before KIIFB for necessary approval and fund allocation.




