ORDER

Government of Kerala have decided to introduce Mass Rapid Transit System (MRTS) in Thiruvananthapuram and Kozhikode cities. Accordingly as per the Government Orders read above Administrative Sanction and other necessary orders were issued for the implementation of Light Metro Rail System in Thiruvananthapuram and Kozhikode at a total estimated cost of Rs. 5510 Crore and Project Completion cost of Rs.6728 Crore. As per the Detailed Project Reports prepared by Delhi Metro Rail Corporation Limited (DMRC), the projects would be taken up as a Joint Venture by the State and Central Governments, with 20% funding by Government of Kerala, 20% by Government of India and the balance 60% from domestic and external borrowings as done in Kochi Metro Project. In the meeting held on 01.08.2016 chaired by the Hon'ble Minister for Public Works, it was decided to take immediate steps for the implementation of Light Metro Projects at Thiruvananthapuram and Kozhikode. Accordingly, as per the letters read above the General Manager, DMRC and the

Managing Director, Kerala Rapid Transit Corporation Limited (KRTL) have furnished proposals requiring urgent action in this regard.

Government have examined the proposals in detail and orders are issued as follows

- 1. Sanction is accorded for Land Acquisition process and posting of a Deputy Collector/Sub Divisional Officer (Revenue) with sufficient staff to expedite the LA process in connection with the Light Metro Rail Projects in Thiruvananthapuram and Kozhikode:
 - a) sanction is accorded for the land acquisition process for an extent of approximately 1.9893 Ha of land comprising of various survey numbers in Pallippuram, Kazhakoottam, Pangappara, Cheruvakkal, Ulloor, Kowdiar, Pattom, Vanchiyoor and Thycaud villages of Thiruvananthapuram Taluk in Thiruvananthapuram District.
 - b) sanction is accorded for the land acquisition process for an extent of approximately 1.4474 Ha of land comprising of various survey nos in Chevayur, Nellikode, Kotooli, Kasaba, Nagaram, Panniyankara and Cheruvannur villages of Kozhikode Taluk in Kozhikode District.
 - c) sanction is accorded for the land Acquisition for flyovers at Sreekaryam, Pattom and Ulloor for an extent of approximately 2.77 Ha of land.
- 2. Administrative Sanction is accorded for flyovers at Sreekaryam, Pattom and Ulloor for an amount of Rs.272.84 Crore (LA cost + Construction cost)
- 3. The expenditure for LA and the construction of above flyovers will be met from the funds mobilized by KIIFB, by availing the funds through the designated agency Kerala Rapid Transit Corporation Limited (KRTL) and implementing the construction works through DMRC as a turnkey project.
- 4. The DMRC will be engaged as a consultant for the preliminary works and scope of work shall include:
 - a) Preparation of land acquisition proposals for the Light Metro Stations, Depots, Electrical Stations etc. including land plans, extents, survey nos. etc.
 - b) Preparations of general arrangement drawings, estimates and

land acquisition proposals for construction of flyovers at Thampanoor and Pattom Ulloor. Sreekaryam, Thiruvananthapuram.

c) Identification of major utilities and preparation of utility

shifting plans

- d) Preparation of road widening plans and land acquisition proposals for Reach 1 (Medical College to Mananchira) in Kozhikode and Reach 2 (Technocity to Kazhakoottam) and Reach 3 (Kesavadasapuram to Karamana) in Thiruvananthapuram
- e) Drawing up of broad specifications for rolling stock by inviting RFQ/RFP from suppliers worldwide, preparation of tender documents for procurement of rolling stock and conducting discussions with suppliers and finalization of the specification for rolling stock.
- f) Offering assistance to KRTL in obtaining approval from Government of India for the project, including providing the necessary inputs for responding to queries, if any, participation in meeting and follow up with the concerned departments like MoUD, the National Institution for Transforming India (NITI Aayog), and Public Investment Board (PIB) etc.

g) Examining and forwarding the recommendations regarding the applications for NOC from Governing Bodies and General Public, for construction of structures along the alignment of

Light Metro Rail.

h) Providing the inputs for responding to various queries, petitions etc. from the general public and Government Departments regarding the Light Metro Rail Projects.

- Soil Investigations, necessary surveys, i) Conducting Excavation Surveys, Collection of data, Detailed design of flyovers etc. for the satisfactory implementation of the project as a turnkey project.
- 5. Sanction is accorded for external funding for debt component of the project from AFD since the JICA loan is a tied fund.
- 6. Remission of tax by way of subordinate debt is an agreed condition while issuing AS for the project and similar benefit was extended to KMRL also.
- 7. DMRC will be engaged as the consultant of the entire project after getting the nod from the Government of India.
