### **Essential qualifications:** /

1) For the Disciplines of Arts, Commerce, Humanities, Social Sciences, Sciences, Languages, Library Science and Journalism & Mass Communication.

Eligibility(A or B):

A.

- i) An eminent scholar having a PhD degree in the concerned/allied/relevant discipline and published work of high quality, actively engaged in reserach with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC listed journals and a total research score of 120 as per the criteria given in appendix II, Table 2 of UGC Regulations 2018.
- ii) A minimum of ten years of teaching experience in University/College as Assistant Professor/Associate Professor/Professor and /or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

#### OR

An outstanding professional, having a Ph. D. Degree in the relevant/allied/ applied disciplines, from any academic institutions (not included in A above)/ industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

#### NOTE:

- 1)A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for direct recruitment of teachers and other equivalent cadres at any level.
- 2)A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward (OBC)(Non-creamy Classes Layer)/Differentlyabled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deafblindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above

are permissible, based only on the qualifying marks without including any grace mark procedure:

- 3)A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- 4)A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- 5)The Ph.D. Degree shall be a mandatory qualification for appointment of Professor.
- 6)The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/ promotion.

#### **Mode of Remittance:**

Application fee is to be remitted through Calicut University Instant Payment System only. The system can be accessed either through the link Instant Web Payment System in the university website(www.uoc.ac.in) or directly through https://www.uoc.ac.in and clicking on the "instant Pay" Tab. The purpose of remittance" APC101 -Application fee for various Posts/Courses" may be selected from the list. If an applicant desires to apply for more than one post separate remittance of fee has to be made.

#### **How to apply:**

- 2) Candidates need to furnish one set of self attested copy of all certificates/documents in support of their claim (this includes copies of certificates proving age, caste/ community, educational qualification, experience-teaching/research projects,research publications and all other achievements including credentials in proof of the API scores claimed) along with the printout of the application.
- 3) Shortlisted candidates have to submit 6 self attested copies of all certificates /documents in support of their claim and original certificates proving age, caste/community, educational qualification, experience teaching/research projects, research publications and all other achievements including credentials in proof of the API scores claimed for verification at the time of interview/screening.

### **GENERAL INSTRUCTIONS:**

- Separate application and fee are required for each post if the candidate is applying for more than one post.

- 5) Candidates who have passed their qualifying examination from Universities outside Kerala should upload the equivalency certificate obtained from this University at the time of application.
- Reservation benefits shall be applicable to only those communities which are mentioned in the KS&SSR. Natives of outside Kerala State will not be considered for the posts which come under community reservation quota.
- 7) The University reserves the Right for cancellation of proceedings, in full or in part, as per this notification without assigning any reason thereof.
- 8) The applicant will be solely responsible for the authenticity of the information submitted.
- Any addendum/corrigendum to this notification will be published only in the website of the University of Calicut and no newspaper notification will be issued.
- 10) NOC from the Employer ,if applicable is to be submitted at the time of application
- 11) No TA/DA shall be paid to the candidates attending the interview.
- 12) Other stipulations prescribed by the UGC /University/Government of Kerala shall be mandatory for all posts.
