# PROCEEDINGS OF THE CHIEF EXECUTIVE OFFICER KERALA INFRASTRUCTURE INVESTMENT FUND BOARD, THIRUVANANTHAPURAM ORDER NO: APR-3/137/2017/KIIFB Dated 16.12.2017

Sub:- KIIFB – Project : GED 005-00 : Upgrading one school from each L.A. Constituency as a Center of Excellence – 9 Sub-projects (25 schools) as Phase III in 12 districts – Approval and Sanction for funding – Orders Issued.

Read:- 1. G.O(Rt)No. 2088/2017/G.Edn dated 29.06.2017.
2. G.O(Rt)No. 3894/2017/G.Edn dated 25.10.2017.
3. Minutes of the 4th Executive Committee Meeting of KIIFB held on 29.11.2017.

Government, through the Budget Speech 2017-18, announced '**Upgrading one school from** each L.A. Constituency as a Center of Excellence', to be taken up as a project funded by KIIFB. Consequently, the General Education Department in Government, vide Government Order read 1<sup>st</sup> above, designated Kerala Infrastructure and Technology for Education (KITE) as the Special Purpose Vehicle for executing the project.

Accordingly, Detailed Project Reports in respect of converting 25 schools in 12 districts as Centre of Excellence were submitted to KIIFB., based on Administrative Sanction issued vide Government Order read 2<sup>nd</sup> above.

The Sub-Projects (9 numbers) submitted were evaluated for adherence to KIIF stipulations, as per GO(Ms) No.315/16/Fin dated 08.08.2016, and were found satisfactory and compliant.

The Appraisal Reports were placed in the 4<sup>th</sup> meeting of the KIIFB Executive Committee for its consideration and approval, abiding by the 29<sup>th</sup> Board Meeting's decision that funding approval up to and including Rs.100 crore in cases of Projects without Revenue streams would be the prerogative of the Executive Committee.

The 4<sup>th</sup> Executive Committee that met on 29<sup>th</sup> November 2017, after considering the proposals and appraisal reports, has accorded sanction for funding the proposal in respect of nine subprojects relating to 25 schools, as appended under the main project - **GED005-00 'Upgrading one school from each constituency as Centre of Excellence'**, to be implemented by the Kerala Infrastructure & Technology for Education (KITE) with a total cost limited to **Rs. 125 crore (Rupees One Hundred and Twenty Five crore)**, against the original proposed cost of Rs. 169.17 Crore subject to the following stipulations

i. Technical Sanction by a competent Authority shall be mandatorily issued before signing schedule/s of the Tri-partite agreement.

- ii. The detailed estimate submitted shall be reviewed by the TS authority considering the applicability and correctness of items in para 7 above, the relevance of Cost Index and adherence of latest PRICE schedule. (Cost index applied on DSR items which has been revised from 01-Oct-2017 & the applicability of the GST also needs to be taken into consideration while according TS.)
- iii. The cost provisions for work alone shall be utilized for execution of work. The savings or anticipated savings from LA, QC, demolition etc. if any, shall not be re appropriated for meeting expenditure of work proper.
- iv. While entrusting the maintenance activities to the contractor, it shall be ensured that the obligation under defect liability shall be performed without any additional cost. Hence no maintenance expenditure is considered under the original work.
- A report of KIIFB premised on the technical appraisal of the project is appended for reference and it shall be taken into consideration by the TS committee while according Technical Sanction to the project.

Sub:- KIIFB – Approval of first tranche of infrastructure projects for KIIFB Funding- Sanctioned-Revised Orders issued.

Read:- 1. Minutes of 27<sup>th</sup> General Body Meeting (1<sup>st</sup> Meeting of the reconstituted Board) of KIIFB.

2. Proceedings of even number dated 18<sup>th</sup> November 2016.

The 27<sup>th</sup> General Body meeting of Kerala Infrastructure Investment Fund Board (KIIFB) has approved 48 infrastructure project proposals with total outlay of **Rs.4004.86.(Rupees Four Thousand and Four Crore and Eighty Six Lakh Only**) and orders were issued as per Proceedings order No. 31/KIIFB/2016, dated : 18.11.2016. Out of the total outlay of 4004.86 the cost estimate for 19 PWD projects is Rs.883.63 Crore. As part of obtaining financial assistance from NABARD, it has been requested to consider the cost mentioned in the DPRs of these projects for funding since the amount mentioned in the DPRs and the cost uploaded in KIIFB Website were different. On considering the DPR Cost of these 19 PWD projects, the total cost of Rs.4004.86 Cr has shown an increase by Rs.17.22 Cr which makes the total outlay for the 48 projects approved by the 27th Board to Rs. 4022.08 Cr.

In the above circumstances, the office Proceedings cited 2 under reference stands cancelled and sanction is accorded to revise the Proceedings for 48 infrastructure project proposals with total outlay of an amount of **Rs.4022.08** (**Rupees Four Thousand and Twenty Two Crore and Eight Lakh Only**) as detailed below :

10. The revenue streams if any shall be identified and communicated as per the requirement of the tripartite agreement.

11. The SPV has to ensure that all necessary clearances are obtained before award of contract.

12. A report of KIIFB premised on the technical appraisal of the project is appended for reference and which shall be taken into consideration by the TS committee while according TS to the project.

In the Revised Budget Speech 2016-17, Government had announced '**Construction of new office buildings for Registration Department**' as a project under KIIFB funding. Administrative Sanction has been accorded, entrusting Kerala State Construction Corporation Limited (KSCC) as Special Purpose Vehicle for execution of the project, vide Government Orders read above.

Accordingly, the Detailed Project Reports (Construction of Building for Sub Registrar Offices at Thrissur, Malappuram and Palakkad Districts) subsequently submitted by the Kerala State Construction Corporation Limited (KSCC) were verified and appraised for adherence to KIIFB stipulations and appraised for compliance, as per G.O(Ms) No.69/2018/Fin dated 24-02-2018.On appraisal, the projects were found satisfactory in terms of all technical and financial parameters insisted upon by KIIFB.

After considering the proposal and the appraisal report, 7<sup>th</sup> Executive Committee held on 25-04-2018 approved the project. Thus, sanction is accorded for funding the project **Tranche 8-RGD007-03: Construction of Building for Sub Registrar Offices at Thrissur, Malappuram and Palakkad Districts cluster-IV**, approved vide Government Order read (2) above, to be implemented by the Kerala State Construction Corporation Limited (Special Purpose Vehicle); limiting the total outlay to **Rs. 17.39 Crore (Rupees Seventeen Crore and Thirty Nine Lakh only)** against the revised proposed amount of Rs.18.15 Crore, as noted below and also with the stipulations there under.

The detailed estimate shall also be checked against the designs and drawings developed. Documentary evidences of these actions shall be communicated to KIIFB prior to acceptance of the tenders
- 4. The cost provisions for work alone shall be utilized for execution of work. The savings or anticipated savings from LA, QC, demolition etc. shall not be re appropriated for meeting expenditure of work proper.
- 5. While entrusting the maintenance activities to the contractor, it shall be ensured that the obligation under defect liability shall be performed without any additional cost. Hence no maintenance expenditure shall be considered under original work.
- 6. A Detailed Appraisal Report of KIIFB is appended for reference and which shall be taken into consideration by the TS Committee while according Technical Sanction to the Project.

In the Budget Speech 2017-18, Government had announced **Elevencherry - Pallassana Comprehensive Drinking Water Project in Palakkad District** as a project under KIIFB funding. Administrative Sanction for the project has been accorded for an amount of Rs. 20 Crore vide Government Order read above.

The Detailed Project Report, subsequently, submitted by the Kerala Water Authority [Special Purpose Vehicle], was verified for adherence to KIIFB stipulations and appraised for compliance, as per GO(Ms) No.315/16/Fin dated 08.08.2016 and found that the project satisfied all the technical and financial parameters insisted upon by KIIFB.

The project proposes a Comprehensive Drinking Water Project with a surface source for meeting the water demand of the project area, which includes Pallasana, Elevenchery, Alathur, Erimayur, Puducode and Kavasseri panchayaths, as the existing facility is insufficient to cater the present water demand of the population and the water supplied is of poor quality.

The Appraisal Report was placed in the 9th meeting of the KIIFB Executive Committee for its consideration and approval, abiding by the 29th Board Meeting's decision that funding approval up to and including Rs.100 crore in cases of Projects without revenue streams would be the prerogative of the Executive Committee.

Thus, the 9th Executive Committee that met on 24th October 2018, after considering the proposal and appraisal report approved the project. Accordingly, sanction is accorded for funding the project TRAN– 10: WRD025-17 - Elevencherry - Pallassana Comprehensive Drinking Water Project in Palakkad District approved vide Government Order read above, to be implemented by the Kerala Water Authority [Special Purpose Vehicle]; limiting the proposed outlay to Rs. 17.58 Crore (Rupees Seventeen Crore and Fifty-Eight Lakh Only), against the proposed outlay of Rs.20 Crore, with the following stipulations:

- The tripartite agreement, as per KIIFB stipulations shall be entered into, after which Technical Sanction shall be mandatorily issued by the TS authority. The Technical sanction by competent authority is mandatory before schedules are added to the Tripartite agreement.
- 2. The detailed estimate submitted shall be reviewed by the TS authority considering the applicability

and the relevance of Cost Index and adherence of latest PRICE schedule. (GST shall be applicable as per the prevailing norms and conditions.)

- 3. The cost provisions for work alone shall be utilized for execution of work. The savings or anticipated savings from LA, QC, demolition etc. shall not be re appropriated for meeting expenditure of work proper.
- 4. While entrusting the maintenance activities to the contractor, it shall be ensured that the obligation under defect liability shall be performed without any additional cost. Hence no maintenance expenditure is considered under the original work.
- 5. The identified revenue streams shall be communicated while signing the tripartite agreement.
- In the wake of the present severe flood, which engulfed most part of the state, the design parameters and calculations for the intake well, WTP, pipe sizes and MFL conditions shall be reviewed prior to TS.
- The TS Committee shall ensure that the distribution systems for the project are either included in this proposal or funds are made available for executing the distribution lines to end consumers before issuing TS for this work.
- 8. The TS shall be issued only after adequacy of source of water is ensured.
- 9. The required statutory clearances as applicable for the project shall be obtained as soon as the Technical Sanction is obtained and prior to the commencement of work.
- 10. Technical sanction may be issued by the SPV only after incorporating the suggestions indicated in the DAR and the compliance may be communicated to KIIFB prior to issuance of tenders.
- 11. The Detailed Appraisal Report of the project is appended for reference and it shall be taken into consideration by the TS Committee while according Technical Sanction to the Project.
