



As per the G.O read as 5th paper above, Government have accorded Administrative Sanction with an estimated cost of Rs.28.47 crores.

2) Subsequently in the meeting held in the presence of Hon'ble MLA on 01.07.2021, it was decided to revise the scope of the project in two phases with vertical expansion and the operational requirement for future expansion. Accordingly, further deliberations were made and it was decided to propose building to B+G+7 with a facility to car parking and CSSD at the base, reduce the waiting area for consultation room,



construction of 10 bedded dialysis unit, and several other rooms for speciality wings etc. The SPV revised the proposal in tune with the same and has submitted a revised estimate to the tune of Rs. 80.41 Crores

3) As per the letter read as 6th paper above, the Director of Health Services has recommended the proposal. Subsequent to the discussion on 09.02.2022, SPV added a dormitory for bystanders with light proof on the terrace floor without changing the amount and has submitted the proposal for approval of the Government.



ORDER

In the COVID Review meeting chaired by the Hon Chief Minister for the next surge preparedness, it was decided to take steps for the construction of isolation blocks at Medical College Hospitals, Thiruvananthapuram and Kozhikode and Isolation wards with atleast 10 beds to 20 beds in the field Hospitals in all the constituencies. Later in the Revised Budget for 2021-22, developing Isolation Blocks in Medical Colleges Thiruvananthapuram and Kozhikode and in various field hospitals of the State Government was included in the Covid Package.

As per the revised Budget Speech for 2021-22, It has been announced that Government will set up ten-bed isolation wards for contagious diseases in all CHC, Taluk, District and General Hospitals. It was also estimated that an amount of Rs.1.75 crore is needed for the setting up of new wards and Rs. 1.25 crore for the renovation of old buildings amounting to a total of Rs. 636.5 Crore for the purpose.

Accordingly, series of meetings were conducted and following decisions were taken.

1. DHS shall submit the list of institutions feasible for developing Isolation Wards.

2. In view of the Covid pandemic and the emergent nature of the project, it was decided that per-engineered technology will be adopted for the buildings to reduce time for project completion.
3. Kerala Medical Services Corporation Ltd. (KMSCL) shall function as Special Purpose Vehicle (SPV) for the project. KIIFB shall place a team of engineers as a Technical Support Unit with KSMCL through its technical resource centre for supervision and monitoring. Any expenditure for specialized services for the execution of the project shall be included in the project cost and any expenditure incurred by the same for the same shall be reimbursed as additional centage charges by KIIFB.
4. The Chief Engineer (Buildings) PWD, Chief Architect PWD with technical experts designated by KIIFB shall prepare type design to do construction on Pre-Engineered technology for speedy implementation of the project.
5. As per the discussions, a technical group comprising of the Technical Committee of Health Department constituted for the purpose of KIIFB funded Health Department Projects and the Chief Architect, Public Works Department shall give the Technical Sanction for this project. Services of experts from the Technical Resource Centre of KIIFB can be availed for assisting this work.
6. The SPV shall identify an agency to execute the project with prior experience of executing multiple projects using pre-engineered structures. For this purpose, in view of the emergent need of completing the project, in the wake of the number of COVID cases and the possibility of any future outbreak of a fresh wave, the SPV may select an agency with prior experience in pre-engineered structures through limited tendering from among the agencies accredited by Finance Department.
7. The financing for the project shall be done as follows - 50% from KIIFB and 50% from MLA SDF (After deducting COVID Funds under ECRP II and Budgetary support from the State Government as may be allocated for the project)

KMSCL has submitted a detailed proposal to KIIFB vide letter read as 6th paper above. The unit cost is Rs. 1.79 crore including GST and contingency charges for 10 bedded unit inclusive of new ward civil works plus essential furniture and equipment. With regard to the construction of the Isolation ward at MCH, Kozhikode and Thiruvananthapuram, M/s HITES have been designated as the SPV vide G.O read as third paper above. The Director of Health Services has submitted the list of 140 institutions wherein the proposed works for establishment of Isolation wards are to be carried out. As per the estimate submitted by KMSCL to KIIFB vide letter read as sixth paper above, the total approximate cost for establishing isolation wards in proposed 140 locations comes to Rs. 259,69,79,300/- (Two hundred and fifty nine crore sixty nine lakh seventy nine thousand three hundred only) (including GST and contingency charges).

Government have examined the proposal and are pleased to designate M/s Kerala Medical Services Corporation as Special Purpose Vehicle for execution of the Project namely "Construction of Isolation Wards in Hospitals under Directorate of Health Services" as per the guidelines issued in Government orders read as 2nd and 3rd above.

Government are also pleased to accord in principle Administrative Sanction for the establishment of isolation wards in 140 locations as annexed to this order subject to the following conditions;

1. Kerala Medical Services Corporation Ltd. (KMSCL) shall function as Special Purpose Vehicle (SPV) for the project.
2. KIIFB shall place a team of engineers as a Technical Support Unit with KMSCL through its technical resource centre for supervision and monitoring. Any expenditure for specialized services for the execution of the project shall be included in the project cost and any expenditure incurred by the same for the same shall be reimbursed as additional centage charges by KIIFB.
3. The Chief Engineer (Buildings) PWD, Chief Architect PWD with technical experts designated by KIIFB will prepare a type design for the construction using pre-engineered structures.
4. The financing for the project will be 50% from KIIFB and 50% from MLA SDF (After deducting COVID Funds under ECRP II and Budgetary support from the State Government)
5. The technical group consisting of Technical Committee and Chief Architect, PWD is authorized to issue Technical Sanction for the project. Services of experts from the Technical Resource Centre of KIIFB can be availed for assisting this work.
6. KMSCL, as the SPV shall identify an agency to execute the project with prior experience of executing multiple projects using pre-engineered structures. For this purpose, in view of the emergent need of completing the project, in the wake of the number of COVID cases and the possibility of any future outbreak of a fresh wave of the pandemic, the SPV may select an agency with prior experience in pre-engineered structures through limited tendering from among the agencies accredited by Finance Department.
7. The SPV shall upload the Administrative Sanction, the project estimates to the portal of KIIFB for emergent financial sanction from the KIIF Board chaired by the Hon'ble Chief Minister.
8. Separate orders will be issued for pooling of KIIFB funds and MLA SDF with the concurrence of the Finance Department.


