Minutes of the 45th Meeting of Kerala Road Safety Authority held on 09-03-2022 at Nava Kairali Hall, Secretariat Annexe 2

The meeting commenced at 4.15pm with Hon'ble Minister for Transport in Chair. Hon'ble Minister for Works & Tourism was also present. The Chairman welcomed the members to the meeting. List of participants is attached as Annexure.

The Chairman remarked that the Agenda & Notes of the Authority meeting should be circulated well in advance, before the Authority Meeting. The Chairman directed Kerala Road Safety Authority to prepare an Annual Budget incorporating the anticipated expenditure towards committed projects, Road Safety projects/programs proposed for the year, administrative expenses etc. The budget should be circulated to Chairman, Kerala Road Safety Authority for approval for the year 2022-23.

The Chairman and Vice Chairman of the Authority observed that as per Section 5(2) of Kerala Road Safety Authority Act 2007, Executive Committee shall be in charge of implementation of the decisions of the Authority. The Chairman observed that the Executive Committee of Kerala Road Safety Authority has no power to suggest that the project should be placed in Kerala Road Safety Authority with the observations/recommendations of the Executive Committee.

As per Section 5(3) of Kerala Road Safety Authority Act 2007, the Executive Committee shall exercise such powers and discharge such functions of the Authority as may be delegated to it, by the Authority. Hence, the recommendations of the Executive Committee to the Authority is not in order as per the existing rules, the Authority decided not to consider the Agenda items 2,9,10 and 11 and the Chairman directed to resubmit those agenda items afresh before the Authority for decision.

Agenda No.1: Confirmation of Minutes of 44th meeting of the Authority and Action Taken on the decisions of the Kerala Road Safety Authority meeting held on 14/07/2021

The Authority confirmed the minutes of 44th meeting of Kerala Road Safety Authority held on 14-07-2021. It noted Action taken on the decisions of 44th meeting of the Authority. The Chairman directed that Kerala Road Safety Authority should take initiative to conduct High Level meeting with Hon'ble Minister for Transport and Hon'ble Minister for Works for discussion on involving SHG for assisting Road Accident Victims as a 'Janakeeya' Program.

Agenda No.2: Overview of Road Safety situation in the State

Ref: A1/44/KRSA/2019

The Authority noted the review of Road Safety situation in the State and directed Road Safety Commissioner to revise Agenda items, in view of the observations made by the Chairman, Kerala Road Safety Authority.

Agenda No.3: Safe Zone Sabarimala Program for the year 2021-22

Ref: A2/948/KRSA/2021

The Authority ratified the sanction accorded to Transport Commissioner for conducting Safe Zone Sabarimala Program for the year 2021-22. The Transport Commissioner informed that out of Rs.68 lakh sanctioned, nearly Rs.37 lakhs was spent for the project and the unspent amount will be refunded to Kerala Road Safety Authority.

Agenda No.4: Installation of Information Sign Boards with road safety messages at 100 bus stops along City Circular Bus routes in Thiruvananthapuram

Ref: A2/901/KRSA/2021

The Authority ratified the sanction of financial assistance of Rs. 15,53,068/- to KSRTC for installation of sign boards carrying Road Safety information along the City Circular Bus Routes in Trivandrum. Hon'ble Minister for Works and Tourism noted that the cost per sign board is higher than that of the sign boards installed by PWD.

The Authority deferred decision regarding purchase of vehicles for Traffic Enforcement Units of Kerala Police at Rs. 8.75 crore. Considering the request of IG(Traffic & RSM), the Authority decided to release balance amount of Rs 6.56 crore for purchase of vehicles to Police department as approved in 34th and 35th meeting of the Authority, subject to the condition that the vehicle should exclusively be used for Road Safety purposes including Road Safety Audit and Road Safety Enforcement as per Kerala Road Safety Authority Guidelines.

Agenda No.17: Skywalk Project in Kottayam town – Traffic study by NATPAC

Ref: A2/1070/KRSA/2020

The Authority took note of Structural Stability Report forwarded by District Collector, Kottayam and accorded sanction to NATPAC for conducting traffic study at Rs. 3.98 lakh + GST.

The Authority further decided that, based on the study report of NATPAC, KITCO should complete the project by strictly limiting to the already sanctioned amount. It was decided to release the funds to District Collector, Kottayam according to the requirement limiting to the original sanctioned amount.

The Authority approved to proceed with Road Safety Awareness program using various media platforms. In connection with the above, the Authority sanctioned the following amount to various media platforms.

- a) Social media – Rs 50 lakh
- b) FM Radio network – Rs 2.5 crore
- c) Jingles in Railway stations – Rs 2.0 crore

In addition to the above, the Authority also approved a provision of Rs 3.0 crore for advertisement on Road Safety Awareness using KSRTC buses and bus stations and Rs.50 lakhs for producing short videos and educational films on Road Safety during the year 2022-23.

One of the main functions of Kerala Road Safety Authority is to implement Road Safety Awareness Programs, the Authority decided to set apart with limit of 10% of Road Safety Fund for various Road Safety Advocacy/Awareness programmes every year.

Agenda No.21: Safe Road to School – A Proactive Program for School Students

The Authority approved NATPAC proposal of conducting Safe Road to School project to selected 100 schools across the State. NATPAC was asked to select the schools throughout the state and furnish the list of schools for approval by the Authority.

Agenda No.22: Promoting Road Safety Awareness Activities to School Students

Ref: A2/144/2022/KRSA

The Authority decided to sanction Rs 50,000/- per school for 100 selected schools across the state towards promoting road safety activities like activity based learning, awareness classes, demonstration of kerb-drill, first aid training, interactive videos on road safety, charts in school premises and related road safety educational activities. It sanctioned an amount of Rs 50 lakhs to selected 100 schools throughout the state subject to the condition that the list of beneficiary schools shall be finalised by the Authority.


