### **ORDER**

As per letter read above, the Chief Engineer, Bridges, Thiruvananthapuram submitted an estimate based on DSOR 2018 for the work 'Reconstruction of Kootar bridge in Nedumkandam- Cumbummettu road (Part of Alappuzha-Madhurai -SH40) in Udumbanchola constituency in Idukki District' seeking Administrative Sanction and Special Sanction for utilizing an amount of Rs. 274.72 lakh under the H/A 5054-03-101-99-00-16.

- 2. The Chief Engineer, Bridges reported that Kootar bridge was a deck slab bridge more than 60 years old located in Nedumkandam Cumbummettu road which was part of Alapuzha Madhurai State highway which connects Kerala and Tamilnadu. The bridge is single lane with 4.0 m wide with no footpath. Flood water rises over the deck slab several times in a year blocking the state highway creating hindrance to transportation of goods and interstate tourists and passengers. No bypass road is available nearby to divert the traffic. The reinforcements are exposed due to spalling of concrete and is corroded. Even though maintenance work was done, the bridge was in a dilapidated condition due to the deterioration of concrete in the foundation, piers and slab.
