As per the Government Order read as first paper above, sanction has been accorded for the implementation of Chief Minister's Entrepreneurship Development Programme (CMEDP) to encourage enterpreneurship in the State and as per Govenment Order read as second paper above, certain modifications were made in the Government Order referred first.

- 2) As per the Government Orders, "In order to support entrepreneurs, State Government will bear 3% interest subvention on the loans released by Kerala Financial Corporation under CMEDP. The subvention is for the entire loan period of five years. The Government liability will be spread over next ten years".
- 3) The Chairman & Managing Director, Kerala Financial Corporation in his letter read as 3rd paper above, has requested to release Rs.74,71,842/- (Rupees Seventy Four Lakh Seventy One Thousand Eight Hundred and Forty Two only)

towards interest subvention for the Financial Year 2021-22, under the head "2851-00-102-23-Assistance to Kerala Financial Corporation towards the interest subvention on Chief Minister's Entrepreneurship Development Programme". As per Government Order read as 4th paper above, an amount of Rs.74.72 lakh has been additionally authorized under the head of account "2851-00-102-23 (P) (V)-'Assistance to Kerala Financial Corporation towards interest subvention on Chief Minister's Enterpreneurship Development Programme' for the Financial Year 2021-22.

- 4) Government have examined the matter in detail and are pleased to release an amount of Rs.74,71,842/- (Rupees Seventy Four Lakh Seventy One Thousand Eight Hundred and Forty Two only) under the Head of Account '2851-00-102-23 (P) for meeting the expenditure towards interest subvention on Chief Minister's Enterpreneurship Development Programme for the Financial Year 2021-22 as envisaged in the Government Orders read as Ist and 2nd papers above, subject to the usual conditions for release of fund.
