The Centre for Parliamentary Studies and Training and the Sabha TV of the Kerala Legislative Assembly was conjoined in March 2021 to form Kerala Legislative Assembly Media and Parliamentary Study Centre (K-LAMPS) with two divisions viz. - ➤ To promote exchange of ideas between Legislators and experts in various fields, including social, economic, scientific, developmental and technical fields, through interactive sessions, seminars, study tours etc leading to enhanced quality of governance and to promote the well being and quality of life of the citizens of the State.
- To provide all stakeholders in parliamentary democracy, the opportunity to understand the importance of the role each of them plays in ensuring the development of the nation.
- To enhance the quality of legislation and rule making by providing opportunities for study and research.
- ➤ To enhance public participation in law making by imparting the necessary orientation and knowledge about the working of various practices and procedure in Assembly.
- To give the youth and children a practical experience of the parliamentary procedures through organising Student Parliaments and Model Assemblies.
- ➤ To ensure proper understanding and implementation of rules by providing training in parliamentary procedures to Government officials of various departments.
- To ensure efficiency of the staff of the Legislature Secretariat through training programmes, discussions, seminars etc.



PART - II

Certificate Course in Parliamentary Practice and Procedure

INTRODUCTION

Indian parliamentary democracy has no match in the world in terms of electoral process, civil liberties, functioning of government, political participation, as the democratic values are part and parcel of the life of the common man in India. A democratic parliament will seek to foster a vibrant civil society and to work closely with it in finding solutions to problems facing the country and in improving the quality and relevance of legislation. Informing citizens about the work of Parliament is not just a concern for the fourth estate, but a responsibility of Parliaments themselves. The Open and Distance Learning System with its inherent flexibility and affordability has emerged as an important mode for providing education and awareness to various sections of the society in the present day educational scenario. Being the forerunner in many democratic innovations in India, the Kerala Legislative Assembly successfully conducts a Certificate Course in Parliamentary Practice and Procedure in the distance education stream to propagate the idea, principle, virtues, philosophy and practice of parliamentary democracy.

NATURE OF THE COURSE

- The Course shall be an awareness and learning programme designed for those who have no experience with parliamentary procedure and for those who are interested in learning parliamentary practices and procedure.
- ♦ It shall be a basic level certificate course on parliamentary practice and procedure.
- ♦ It shall be conducted in distance education mode and shall include contact classes / online classes along with assignments and workshops.
- The Course shall be managed, regulated, conducted and controlled by the K-LAMPS(PS) which was established as an integral division of the Secretariat of the Kerala Legislature.
- Decision of the Centre shall be final in all matters related to the course, including academic, administrative, financial as well as matters not expressly dealt with printed or online documents.

ELIGIBILITY FOR ADMISSION

- Minimum qualification for applying for the Course will be a pass in Higher Secondary or equivalent qualification as approved by the Universities in Kerala (Pre-Degree / Plus two or equivalent)
- Those who are awaiting results of the qualifying examinations are also eligible to apply.
- Maximum number of seats shall ordinarily be 500 (Five hundred) for an academic session or as decided by the Governing Body for the Course.
- ♦ Minimum number of students to commence a batch shall be 10 (Ten).
- There shall be Admission fee and Course fee for admission to the Course.
- Admission will generally be open to all eligible candidates and there will be no upper age bar for admission to the course.

REGISTRATION

A student shall be considered to have 'Registered' in the course only if he/she remits the Admission fee, Course fee and Examination fee and submits the Application for Examination on time. Such Registered candidates only shall be eligible to appear for exams in four consecutive chances. However, he / she will be required to pay exam fee every time he / she wishes to appear for exams within this period.

DURATION OF THE COURSE

Duration of the course shall be six months.

CONTACT CLASSES

- Personal Contact Programmes (PCPs) shall ordinarily be arranged by the K-LAMPS (PS) to facilitate interaction between the learners and subject experts, who give due academic counselling to the learners.
- Contact class centres shall ordinarily be at Thiruvananthapuram, Ernakulam and Kozhikode or as decided by the K-LAMPS (PS). Days (5 or 6 in total) of contact classes will be notified on the official website as well as via SMS to registered mobile numbers of learners.
- If situations arise which prevent holding of contact classes, online classes will be arranged.

MEDIUM OF INSTRUCTION

Medium of instruction shall be English and Malayalam.



STUDY MATERIALS

Study materials prepared by K-LAMPS(PS) will be printed and supplied to the learners. While these Self Learning Materials (SLMs) give the learners the required academic guidance, learners are advised to supplement with their reading by thoroughly going through the books suggested for reading.

SYLLABUS

Syllabus and books suggested for reading are shown as Annexure-1.

EXAMINATIONS

- Examinations will be conducted at the end of the course and the centres of examination shall ordinarily be at Thiruvananthapuram, Ernakulam and Kozhikode.
- Application for examination shall be made in the prescribed form along with the prescribed fees.
- Medium of examination shall be English or Malayalam.
- Learners have to submit an assignment for each paper within the stipulated time. Learners also have to appear for written examination for four papers and a combined viva voce for all four papers.

Note:-

- 1. The bank charges for remitting the fee should be borne by the learner himself.
- 2. Learners belonging to Scheduled Castes and Scheduled Tribes are eligible for fee exemption as applicable to the students undergoing studies under the Institute of Distance Education of the University of Kerala. However all applicants are required to pay the fee for Application Form and Prospectus (₹100) and the fee for admission (₹250).*
- 3. The status of an applicant (student / not a student) at the time of admission / remittance of the course fee will be deemed to be his / her status for the entire duration of the course. However in the case of re-registration following the lapse of four consecutive chances, the status shall be that as the case may be at the time of admission / remittance of the course fee.
- Fees and fines are to be remitted directly or via Online transfer to the Account No 37005174195 maintained in the Vikas Bhavan Branch of SBI with IFS code SBIN0070415.
- 5. Fees and Fines once remitted will not be refunded.

VERIFICATION OF ORIGINAL DOCUMENTS FOR FINALISATION OF ADMISSION

- ♦ A learner's enrolment shall remain purely provisional and may be cancelled subsequently on grounds of non-fulfilment of minimum eligibility criteria, dependent on the verification of his/her original documents to the satisfaction of the Centre. Learners are therefore required to produce the original documents (copies of which submitted with the application form during admission) for verification on such dates as will be notified.
- Admit Cards for appearing at the Examination will in no case be issued until all the documents in original are submitted and verified and all fees and fines are remitted.

CANCELLATION OF ADMISSION

Apart from the non-fulfillment of basic eligibility criteria, admission of a learner may be cancelled by the K-LAMPS (PS) without refund of the fees and fines deposited on any of the grounds mentioned below:

- Suppression of information or submission of false information found at any stage after admission;
- Misconduct/indiscipline; and
- Adoption of unfair means at the examination hall and any other matter found objectionable by the K-LAMPS (PS).

Parliamentary Internship Programme

The Parliamentary Internship Programme (PIP) aims to provide an opportunity to students of Law Colleges to acquaint themselves with the functioning of parliamentary democracy and democratic institutions in general, Indian parliamentary system and specifically about the legislative procedure and activities of Kerala Legislative Assembly. The Programme also aims at imparting requisite skills and knowledge to enable the interns to develop a proper perspective about the role of Legislature in the parliamentary system which, in turn, will help them while working in their judicial career. A number of students, from Law Colleges all over India regularly do their internship from the K-LAMPS (Parliamentary Studies).

- A programme 'Festival on Democracy' consisting of several National Conferences on various topics of national interest was inaugurated on 06 August 2018 by the Honourable President, Shri Ram Nath Kovind.
- National Legislators Conference on "Challenges in the Empowerment of Scheduled Castes and Scheduled Tribes in Independent India" was held on August 6th and 7th, 2018. Elected representatives from all over India deliberated on various issues and brought out the "Thiruvananthapuram Declaration" on the topic.
- National Students' Parliament was held from 23rd to 25th February, 2019 with the participation of over 2000 young men and women from Universities all over India and interaction with over 50 eminent leaders from all walks of life. The youth of India voted and passed resolutions in the various sessions and pledged to work for the unity, integrity and prosperity of all citizens.
- The K-LAMPS, on 2022 May 26, 27, conducted a two-day national conference of women legislators from all over the nation under the theme 'Power of Democracy'. The conference named the 'National Women Legislators' Conference, Kerala-2022'



was inaugurated by the then Hon'ble President of India Shri Ram Nath Kovind. Through this venture Kerala Legislative Assembly tried to bring together all elected women representatives from both Houses of Parliament, State Legislatures, State Councils as well as Union Territories to the Kerala Legislative Assembly, Thiruvananthapuram on May, 2022 for a two-day brainstorming session.

Annexure – 2 SCHEME OF EXAMINATION

- Maximum Marks for Examination (Papers I to IV) 100 x 4 = 400 Marks.
- Out of the 100 marks each for Papers I to IV, 80 marks is for written exam, 10 marks each shall be for Assignments and Viva Voce related to the paper. A minimum of 5 marks out of 10 (50%) is necessary for a pass in assignment of each paper. However a total of 40% out of maximum 90 marks is necessary (marks obtained for Assignment (maximum 10) PLUS marks obtained for written examination (maximum 80)) for a pass in each paper. A minimum of 20 marks out of 40 (50%) is necessary for a pass in viva voce, which will be considered separately.
- Duration of Exam for Papers I to IV shall be 150 minutes per paper.
- A combined viva voce for all four papers will be conducted at the end of the course that carries forty marks in total.
- The Board for the Viva Voce shall be as decided by the Governing Body of the Course.





