Dear Sir,

I would like to invite attention to your D.O. Letter No.1-2/2022-IS.19 dated, 03/02/2025 regarding the implementation of the PM SHRI scheme. In this connection, it may please be noted that the State has not yet received any funds for Samagra Shiksha from the Ministry of Education as Central share during the financial year 2024-25. However, Government of Kerala is advancing the fund for minimal programmes so that the Project maintains its momentum. But the State would find it difficult to fund all the programmes of Samagra Shiksha and it would affect the implementation of the schemes for the school students.

As directed in the PAB meeting for Samagra Shiksha Kerala for the year 2024-25, the State Project Director had submitted the proposal for release of funds with all the connected documents vide letter No. F1/3584/2024/SSK dated 06.05.2024, and subsequent reminders were sent to the Ministry of Education thereafter. My DO letter No.P1/144/2024/GEdn dated 10.09.24 requesting to release at least the first instalment of Samagra Shiksha funds may also please be seen. All the review meetings held during this financial year by the Ministry of Education for fund release show that the Kerala Government has fulfilled all the conditions/guidelines for releasing the fund for Samagra Shiksha, and the reason for not releasing the Central share is the non-signing of PM SHRI MoU.

Even though we have reached the fag end of the financial year, the State Government is not in receipt of even the spillover amount for the previous year for re-imbursement as mentioned in the minutes of PAB held on 27.05.2024 (the first instalment for the Financial Year 2024-25). I may take this opportunity to inform you that the signing of the PM SHRI Scheme is under the consideration of the State Government.

In the circumstances, I request to please give necessary direction to release the Central share funds for Samagra Shiksha as approved by the PAB for the financial year 2024-25 in order to continue the implementation of the Scheme. The shortage of funds has badly affected the ongoing activities of Samagra Shiksha Kerala and its goal is at stake. The projects for vocational education, the support for children with special needs and benefits like uniform and textbooks for the students have been affected due to non release of funds by the Ministry of Education in the financial year 2024-25. The letters sent to Government of India regarding non receipt of funds are attached herewith for your kind consideration.

Hence it is requested to please release the Central share funds for Samagra Shiksha for the financial year 2024-25 in the interest of quality education to the children of the State.

I would like to invite attention to the letter No. F1/3584/2024/SSK from the State Project Director, Samagra Shiksha Kerala dated 06.05.2024 regarding submission of proposal with connected documents for the release of the first instalment of Samagra Shiksha funds for the year 2024-25. During the financial year 2023-24, Samagra Shiksha Kerala had received the first and second instalments as Rs.7052.87 lakhs and Rs.7052.69 lakhs respectively from the Central Government, out of the total approved Central share of Rs.32883.07 lakhs.

As per the direction given by the Ministry of Education, Samagra Shiksha Kerala had submitted the proposal for the release of 37.5% of the total Central share, as there was no sufficient time to release the third and fourth instalments of Central share, on 18.03.2024 as per letter No. F1/4364/2024/SSK. But no fund was released by the Ministry of Education till 30.03.2024. In compliance with the discussions held with the Ministry of Education on PM SHRI scheme and on direction of the Government of India letter No. D.O No.1-2/2022-IS-19 dated 23.02.2023, D.O letter No.GE-JA1/39/2023-GEDN dated 30.03.2024 regarding assurance of signing of MoU for establishing PM SHRI was sent to the Ministry of Education.

However, the last instalment for the year 2023-24 was not released due to technical reasons. A detailed proposal for the reimbursement of recurring expenditure incurred by the State during the financial Year 2023-24 was submitted by Samagra Shiksha, Kerala on 09.04.2024 in consultation with the Ministry of Education.

The meeting of the Project Approval Board for the Financial Year 2024-25 held on 27.05.2024 considered the request of SSK for supplementary proposal and as per the minutes of the meeting, the Project Approval Board approved an outlay of Rs.15335.37/- lakhs as reimbursement, out of which, the Central share is 9201.22 lakhs. It was also decided to include the reimbursement amount in the outlay for the current year, i.e. 2024-25. The PAB also agreed to enhance the spillover figures to Rs.6052.20 lakhs. Therefore, the revised outlay for the year 2024-25 as per the PAB minutes is as follows:-

Samagra Shiksha Kerala submitted the proposal for the first instalment for the year 2024-25 vide letter No. F1/3584/2024/SSK dated 06.05.2024 with a reminder letter on 07.08.2024. But the Ministry of Education has informed that fund can be released only after signing the MoU for PM SHRI Scheme. The status of fund release presented by the Ministry of Education on 10.07.2024 at the review meeting held on 9th and 10th July regarding the release of funds for the current financial year showed that the State Government have fulfilled all the conditions/guidelines for the release of the first installment and the reason for not releasing the Central Share is remarked as 'PM SHRI MoU yet to be signed'.

The State is processing the file of PM SHRI Scheme and has agreed to sign the MoU in principle and the same is under process. The State Project Director, SSK had already ventilated their concern and plight and requested for the release of 37.5% of Central Share in 2023-24 as per letter No. F1/4364/2023/SSK dated 20.03.2024 and for the release of 1st installment in 2024-25 as per letter No. F1/3584/2024/SSK dated 06.05.24 and 07.08.2024. But the State have not received any fund for Samagra Shiksha so far in the financial year 2024-25. Yet, State Government of Kerala is advancing the fund for minimal programmes so that the Project maintains its momentum.

In the circumstances, considering the assurance given by the State Government regarding the signing of the MoU for PM Shri scheme and the action taken to process the file of PM Shri scheme, it is kindly requested to please give necessary direction to release at least the first instalment of Smagra Shiksha for the year 2024-25 in order to overcome the financial constraints and to run the programmes of Samagra Shiksha smoothly.





Your kind attention is invited to the references cited above. As per the approved AWP&B for 2024-25, an amount of Rs. 85590.46 lakh was sanctioned as the total estimated budget for Samagra Shiksha Kerala for 2024-25, which includes the reimbursement of Rs 15335 37 lakh for the year 2023-24

As per the Ref(2) letter cited, the proposal was submitted for the release of 1st installment of fund for 2024-25. Reminders in this regard were sent on 07-08-2024, 18-09-2024, 24-10-2024, 16-11-2024, 27-12-2024 & 25-02-2025.

I am pleased to inform you that the Government of Kerala has decided to sign the MoU of PM-SHRI Scheme. Currently the file is with the Hon'ble Chief Minister of Kerala and it will be placed before the Cabinet in the first half of April 2025. The MoU is expected to be signed in April 2025 itself. In the circumstance, I request you to approve the proposal submitted herewith and release funds for Samagra Shiksha Kerala.

The State Government has already incurred substantial expenditure covering both actual expenses and committed costs for FY 2024-25. The total of committed and incurred expenditure stands at ₹56748.07 lakhs. Given this situation, we urgently seek the release of the Central Share of the above expenditure.

Additionally, as per the addendum to the PAB minutes dated 31.01.2024, an amount of Rs. 15335.37 lakh was approved as reimbursement for the year 2023-24, with its Central Share being Rs. 9201.22 lakh. We request you to the release of this pending amount as well.

Along with the reimbursement amount of Rs.15335.37 lakh, we urgently request the release of 50% funds sanctioned for 2024-25 to cover the following committed expenses.

Due to lack of sufficient funds, Samagra Shiksha Kerala is struggling to extend its services to marginalized students, including Children with Special Needs and those from Scheduled Tribes. Therapy services in autism centers have also been affected.

Moreover, funds we're expended to hostels under Samagra Shiksha Kerala, including KGBV, as they were on the verge of closure due to fund shortages. Students, particularly from tribal settlements, were facing hardships as funds for uniforms, textbooks, and other essentials were not received.


Even though Samagra Shiksha Kerala has not received any Central Share in this financial year, we have already remitted the interest accrued on the Central Share as per SNA 04 (A) Report.

We confirm compliance with all instructions issued by the Ministry of Finance, Department of Expenditure, as per OM dated 23.02.2022 and corrigendum dated 28.03.2022.

In these circumstances, we urgently request the release of the full amount of reimbursement for year 2023-24 and 50% of the expenditure incurred and committed during 2024-25. It is also requested to release the balance amount as reimbursement for the year 2024-25, to be released in 2025-26.

Kind attention is invited to the references cited. As per the Ref. (2) letter cited, the proposal was submitted for the release of 1st installment of fund for Samagra Shiksha Kerala for the year 2024-25 to the Ministry of Education, Government of India with all related documents.

Reminders in this regard were sent on 07.08.2024, 18.09.2024, 24.10.2024 and 16.11.2024 as per ref. (3) and (4). But the 1st installment of fund for Samagra Shiksha Kerala for the year 2024-25 has not been released by the Ministry of Education, Government of India, till date.

Sir. our State is in dire need of funds and is unable to meet the needs of marginalised students, especially Children with Special Needs and Scheduled Tribes Needless to say, you are already aware that the CWSN students, especially those who need Ortho equipment, are severely affected by lack of equipments as they have not been provided with it. By not providing ortho equipments, CP chair, hearing aids we are denying them access to justice, equity and barrier free education. For many families accessing such equipments privately is financially not feasible. We hereby request the Ministry of Education to continue supporting these students with essential orthopedic and hearing equipments, ensuring that CWSN receive the care and support they need.

The situation is not different in the case of therapy services in Autism centres. Somehow we have managed to give therapy services to the needy children till this month. But now we are not in a position to extend this service without any financial support from the Ministry of Education. You may also know that availing private therapy services is often unaffordable for many families and discontinuing these

services would be a set back on the children's progress. We request the Ministry of Education to release fund for the therapy services so that we can ensure them consistent support and progress. I may also bring to your kind attention the plight of special Educators who are serving without salary for the last 5 months. Majority of them survive on this single source of income which itself is meagre. So kindly release the salary of Special Educators as well.

The hostels under Samagra Shiksha Kerala including KGBV are about to close due to lack of funds. As these hostlers are mostly from tribal, social and economically vulnerable sections it would leave the children into poverty, social injustice and resultant dropping out. So we humbly request the Ministry of Education to release fund for hostels urgently for protecting their Right to Education.

The students especially from the tribal settlements, consider their school uniform as a good dress to wear outside also. Without uniforms they consider themselves behind all the other children and this may result in dropping out and the significant increase in the number of out of school children across Kerala in the coming years. We kindly request the Ministry of Education to allocate sufficient fund for uniforms, so that the child can study with dignity and confidence.

I hereby confirm the compliance of instructions issued by the Ministry of Finance. Department of Expenditure's OM Dated: 23.03.2022 and Corrigendum Dated: 28.03.2022.

In the circumstance, I would like to request you to take urgent necessary steps for the release of first two installments of Central Share to Samagra Shiksha Kerala at the earliest so that we are in a position to meet the following urgent expenditure.



It is high time that Ministry of Education is intervened in this matter with utmost gravity and facilitate smooth functioning of the project by releasing the first two instalments.



Kind attention is invited to the references cited above. As per the reference 1, we have requested the release of the first installment of funds for Samagra Shiksha Kerala for the year 2024-25. In addition, we have also given another letter (reference 2) regarding the release of funds to provide assistance to children with Special Needs.

Although, we have submitted multiple letters requesting the release of the approved funds as per PAB minutes, we have not received any funds.

The Children With Special Needs in our State are facing difficulties due to the lack of released funds. They are strugg ing to access CWSN friendly education which can only be ensured through the supply of assistive devices, various allowances and therapeutic services. In light of this I request you to release the support for Inclusive Education interventions at the earliest, so that they can overcome their physical and academic challenges.



Kindly refer to the Government Orders cited. With reference to the release of State share, Elementary Education, Government of Kerala as per para 2 (1) of the Government Order 1st cited had prescribed that 25% of the State share of the Elementary Education would be met by the Local Government. In subsequent years the percentage has been increased to 40% which is evident from the Government Order read as second paper above SNA account has been opened for Samagra Shiksha Kerala with effect from 06-07-2021. Since then all the central and state share releases had been reflected in the SNA 01 and SNA 06 report for the year 2021-22 except the State share of Elementary Education which was directly remitted to SNA account by the LSGDs concerned on the basis of the Government Orders cited and hence not routed through Treasury. It may also be noted that SSK has actually received an excess amount by Rs.50 lakhs during the year 2021-22 which is well above the 40% matching State share.

In 2022-23 Government of Kerala has opened a separate Head of Account for providing funds under State share for Elementary Education as advance vide reference 4th cited. Hence entire State share of the Samagra Shiksha Kerala is now being routed through State Treasury and is reflected in the SNA report. Hence one time exemption may be granted for the year 2021-22, considering the above facts.

The documents showing creation of dedicated Head of Account providing State share of Elementary Education 2022-23 and copies of the letters cited are also attached for reference.
