W.P.(C) No.16456 of 2021 filed by Dr. Anupama. K.P. എന്ന കേസിൽ ബഇമാനപ്പെട്ട സിംഗിൾ ബെഞ്ച് താഴെ പറയുന്ന വിധി പുറപ്പെട്ടവിക്കുകയുണ്ടായി :

In the first blush, by looking at the appointment chart, Ext.P6, apparently it is seen that the 54th rotation has gone to the Physically handicapped, which has been kept as NCA against Journalism and Mass Communication but on going through the counter affidavit which has gone unrebutted, it is not so. For 2nd slot in the stream of School of Drama and Fine Arts one Sandeep Kumar has been appointed and and for 54th slot Dr.Promod C in the stream of Botany has appointed. The relevant portion of the same reads thus:

For all intents and purposes, there is no violation of the roster point against the 100 point, which is intandem with the provisions of KS&SS Rules and the amendment caused therein in 2020. Apprehension of the petitioner is wholly misplaced. No ground for interference is made out. Writ petition is accordingly dismissed.

W.A. No. 1527/2021 against the judgement dated 6TH DAY OF OCTOBER 2021 of the Single Bench in W.P.(C) No. 16456/2021.എന്ന കേസിൽ ബഇമാനപ്പെട്ട ഹൈക്കോടതി ഡിവിഷൻ ബെഞ്ച് താഴെ പറയുന്ന വിധി പുറപ്പെട്ടുവിച്ചിട്ടുണ്ട് :

i. The University is directed to appoint the petitioner as Assistant Professor in the Department of Journalism and Mass Communication in the vacancy corresponding to roster point 54 forthwith.

ii. The University is also directed to rework the rotation chart in respect of the appointments already made pursuant to Ext.P1 notification notionally, following the procedure prescribed by the apex court in Indra Sawhney,Anil Kumar Gupta and Rajesh Kumar Daria and retain persons who are appointed otherwise than in accordance with the said procedure in super numerary posts, so that they will not be affected by this decision and the University will be free to adjust their appointments against future vacancies as and when they arise.

iii. It is clarified that the process of reworking theroster chart as directed,the University would be free to make up the shortfall due to the category "persons with disabilities", if qualified hands are available among the applicants for and if the reservation in favour of the "persons with disabilities" cannot be completed even following the same procedure,the shortfall can be made up by ear marking the requisite number of vacancies next arising in the category of Assistant Professor for the category "persons with disabilities"

iv. It is also clarified that the direction contained in the judgement will not affect the rights of parties in pending writ petitions where the selection and appointments made pursuant to Ext.P1 notifications are already under challenge

W.A. No. 1527/2021 വിധിക്കെതിരെ കാലിക്കറ്റ് സർവ്വകലാശാല ബഇമാനപ്പെട്ട സുപ്രീം കോടതിയിൽ ഫയൽ ചെയ്ത Petition(s) for Special Leave to Appeal (C) ( SLP No. 10045/2023) ൽ ബഇമാനപ്പെട്ട സുപ്രീം കോടതി 19.5.23 ൽ താഴെ പറയുന്ന വിധി പുറപ്പെട്ടവിക്കുകയുണ്ടായി :

"Taking note of the above, we are clearly of the opinion that 3 the additional slots in between for persons with disabilities could not have been provided in the roster point. The respondent herein was the second in merit for the second vacancy that would be available for the Department of Journalism and Mass Communication. Therefore, the High Court has rightly directed that the process adopted by the University in applying the roster point was faulty and is contrary to the decisions in Indra Sawhney v. Union of India, 1992 Supp (3) SCC 217, Anil Kumar Gupta v. State of U.P., (1995) 5 SCC 173 and Rajesh Kumar Daria v. Rajasthan Public Service Commission, (2007) 8 SCC 785. The Special Leave Petition is accordingly found devoid of merit and the same stands dismissed. Pending application(s), if any, shall stand closed"

W.P.(C) No.4733/2021 filed by Dr. Rasheed Ahamed P & connected cases ( WP(C) No.16078/2021 , WP(C) No.16407/2021 , WP(C) No.7250/2022 , WP(C) No.19805/2023 , WP(C) No.25315/2023 , WP(C) No.25325/2023 , WP(C) No.25602/2023 , WP(C) No.39324/2023 , WP(C) No.10898/2024 ) ൽ താഴെ പറയുന്ന വിധി പുറപ്പെട്ടവിച്ചിട്ടണ്ട് :

" In the light of the aforesaid observations and findings, I hold that, the issue regarding the manner of implementation of reservation for physically disabled persons, while conducting the selection process of Assistant Professors based on Ext.P1, is already concluded by this Court in Ext.P6 judgment. The contentions raised by the University justifying Ext.R1(a) are not acceptable in view of the fact that, all those contentions were in fact considered by this Court in Ext. P6 judgment and were rejected. Therefore, the University cannot reagitate the matter in this writ petition, particularly since the directions in Ext.P6 are already confirmed by the Hon'ble Supreme Court. Therefore, the respondent-University is directed to rework the rotation chart, by strictly following the directions issued by this Court in Ext.P6 judgment. As regards the reliefs sought by the petitioners in WP(C) Nos.7250/2022, 16078/2021 and 16407/2021, it is observed that, even though the contentions of the petitioners regarding the erroneous application of reservation policy are upheld, the reliefs sought by them to interfere with the appointments already granted to the party respondents is declined for the reasons mentioned above." The University is directed to issue appropriate orders in this regard by strictly implementing the observations in the judgment of this Court in WA 1527 of 2021 with in a period of 3 months from the date of receipt of a copy of this judgment."

# **JUDGMENT**

# Dated this the 30th day of November 2020

Petitioner, who is a postgraduate degree holder in Hindi with M.Phil, NET, B.Ed and Doctoral Degree eligible to be appointed as Assistant Professor in the University of submitted Calicut, an application pursuant to the notification Ext.P3 dated 31.12.2019. The age limit, in the aforementioned notification was prescribed as on 1.1.2020 for Assistant Professor below 40 years. Learned counsel for the petitioner submits that on commencement of the Public Services (Date for determination of age for eligibility and appointment) Rules 1977, the determination of age for eligibility for appointment to the post included in various services was modified as on 1st January of the year in which application for appointment to such posts are invited. Since the notification concededly was published on the eligibility date on the notification was 31.12.2019, mentioned as on 1.1.2020 which is against the mandate of

the aforementioned Rules, as the applicability of the aforementioned Rules has been admitted on perusal of the averments in para 10 of the counter. It is in this circumstances, the petitioner had to approach this Court as his application was not accepted being over aged. This Court vide interim order dated 3.2.2020, directed the respondent to consider the hard copy of the application of the petitioner with a caveat that it will not be construed as a right in favour of the petitioner to participate in the process of selection in this behalf.

- 2. It is further pointed out that the respondents have fixed the date of interview on 1.12.2020 ie., tomorrow. In an interim application, the petitioner has requested for the intervention of this Court to participate in the process of selection process.
- 3. On the other hand, learned Standing Counsel appearing on behalf of the University, submits that the application of the petitioner for appointment to the post of Assistant Professor was rejected on the ground of the overage. As per the Government order dated 17.8.2019, the upper age limit of Associate Professor as 45 was

Δ

dispensed with. In this circumstances, the University did not fix any age limit to the Associate Professor and Professors in the notification but the post of Assistant Professor, being an entry cadre, the University followed KS&SSR, also followed by Kerala PSC and the upper age limit has been fixed as 40. As per the judgment of the Hon'ble Supreme Court in **Dr.Ami Lal Bhat v. State of** 1997 SC *72*). Rajasthan (IT *(6)* it is prerogative/discretion of the University for determining the minimum/maximum age required for a post. Thus, there is no ambiguity in fixing the age limit as 40. However, did not deny the factum of non applicability of the aforementioned Rules.

4. I have heard the learned counsel for the parties and appraised the paper book. Rule 2 of Public Services (Date for determination of age for eligibility and appointment) Rules 1977 reads thus:

"Date for determination of age for eligibility for appointment to Public Services – With effect on and from the commencement of these rules, the Special Rules for the various State Services and Subordinate Services, in force at such commencement, shall stand modified as if the date specified in those Special Rules for determination of the age for eligibility for

appointment to posts included in the various services had been modified as the 1<sup>st</sup> January of the year in which applications for appointment to such posts are invited:

Provided that nothing in this rule shall apply to any appointment to be made in pursuance of any notification inviting applications, published before the commencement of these rules."

As per the Rules, the petitioner would not be an over aged for the aforementioned post but the respondents as per the notification considered the age limit as on 1<sup>st</sup> January 2020. In my view, the decision of the respondent in ordering the consideration of age limit as 1.1.2020 is against the mandate of Rules and not sustainable in the eyes of law. Accordingly, the date mentioned in the notification as 1.1.2020 is hereby expunged and ordered to be considered as 1.1.2019, strictly in accordance with the Rule 2 ibid. There is no regarding the age of the petitioner to be dispute considered as on 1.1.2019, who would be falling within the zone of consideration for the post of Assistant Professor. As per the settled law, a person is only liable to be considered, however the aforementioned right of consideration is being taken away, owing to the

petition is allowed. The respondents are directed to consider the application of the petitioner to be eligible and allow him to sit in the interview of the selection process on 1.12.2020. However, it is made clear that consideration for his appearance in the interview would not be construed as an appointment, but only as a right of consideration.

# **JUDGMENT**

The petitioner, an applicant to the selection to the post of Assistant Professor in Comparative Literature at the Department of Russian and Comparative Literature at Calicut University, has filed this writ petition contending that the sixth respondent, the selectee, did not have the eligibility fixed in Ext.P1 notification. The relevant qualifications in Ext.P1 are as follows:-

- "i) A master's degree with 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign University.
- ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum standards and Procedure for award of Mphil/Ph.D Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then



existing Ordinances/ Bye-laws/Regulations of the Institutions awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D degree of the candidate has been awarded in a regular mode:
- b) The Ph.D thesis has been evaluated by at least two external examiners:
- c) An open Ph.D viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D work, out of which at least one is in a referred journal;
- (e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs of the University concerned."

2. The petitioner submits that the sixth respondent did not have NET qualifications and that in cases where a person did not have NET, the qualifications mentioned at (d) and (e) of the notification are mandatory. The petitioner asserts that the sixth respondent does not comply with conditions (d) and (e) in Ext.P1 notification, as the sixth respondent has not published two research papers from her Ph.D work, out of which at least one must be in a referred journal. Likewise, the contention that the sixth respondent has also not presented two research papers based on a



Ph.D work in conferences seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any other similar agency. It is also stated that the sixth respondent was awarded Ph.D as per the certificate dated 4.10.2012, and as of that date, the sixth respondent has not met the said conditions. The research papers for seminars attended after the awarding of Ph.D are not relevant. Therefore, the petitioner contends that even if the sixth respondent had Ph.D in the subject by registering for the Ph.D programme before 11.07.2009, she is not eligible for exemption from the NET for the reason that she had not fulfilled the conditions (d) and (e) mentioned while taking her Ph.D.

3. Though the petitioner had arrayed, the seventh respondent pleading lack of eligibility, since the seventh respondent had already got an appointment elsewhere and is not interested in the post in question, the petitioner is not claiming any relief against the seventh respondent. Apart from this, the petitioner also raised an allegation against the sixth respondent that in the research papers of the sixth respondent, there was plagiarism and an enquiry was ordered, and the committee that looked into the said allegation found merit in the allegation, as is seen from Ext.P5 and the same was referred before the Syndicate which later on dropped the same. It is alleged that the Syndicate committee dropped the charges against the sixth respondent only out of the influence that the sixth respondent had in the University.



4. The sixth respondent has filed a counter in the above case. The sixth respondent denied all the charges against the petitioner and submitted that she took M A Degree in Comparative Literature from the first respondent University in January 2003 with first rank. She also secured an M.Phil Degree in Comparative Literature in June 2005 from the first respondent with an A Grade. She also obtained a Ph.D. in Comparative Literature awarded by the first respondent University on 4.12.2012. These are evident from Exts.R6(a) to R6(d). It is also pointed out that she has five years of teaching experience as a Guest Lecturer in the Department of Russian and Comparative Literature at the first respondent University. The petitioner claims that she is fully qualified and that she has been given a certificate in that regard, as stipulated in the notification, from the university. The contention that she does not have NET qualification is not relevant as a person awarded with the Ph.D. degree in accordance with the UGC Regulations 2009 or 2016, or their amendments from time to time as the case may be, are excepted from NET/SLET/SET. Since she had a Ph.D. qualification and an index mark of 85.33 out of 100, she was included in the rank list based on her performance in the interview. It is also pointed out that the petitioner has also participated in the selection process and, therefore, is estopped from challenging the selection process after having failed in the same. The allegation of plagiarism is also denied. The sixth respondent points out that she had filed WP(C)No.33313/2016, which was closed after recording the submission of the University that the Syndicate



has decided not to proceed further. It is also pointed out that the petitioner has not impleaded all the persons in the rank list, and hence, the writ petition is bad for the non-joinder of necessary parties.

- 5. A counter affidavit is filed on behalf of respondents 1 to 3; namely, the University stating that the sixth respondent is qualified and that conditions (d) and (e) in Ext.P1 notification were verified. It is only after the same that the Registrar issued the certificate as required in Ext.P1 itself. It was only after assessing the eligibility of the participants that they were included in the ranked list. The University also denies the allegation of plagiarism. The University has also produced the certificate, which was issued at the request of the sixth respondent in terms of the regulations for claiming exemption from the NET to apply for the post of Assistant Professor as she had registered for the Ph.D. programme before July 11, 2009, and had obtained Ph.D in terms of the UGC Regulations. The University, after verification of the records, issued a certificate on 17.01.2020, which is marked as Ext.R1(a). The University asserts that the candidate had published two research papers in a referred journal from out of her Ph.D. work and that she had also participated, as is seen from the certificates produced by the sixth respondent.
- 6. Heard Sri. Lindons C. Davis, the learned counsel for the petitioner, the learned senior counsel Sri.Jaju Babu, instructed by Sri.Brijesh Mohan and Sri.P.C.Sasidharan, the learned standing counsel for Calicut University.



7. The essential qualifications as extracted above and which arise for consideration in this case are qualifications marked as (d) and (e) in Ext.P1. The sixth respondent has produced Ext.R6(i), which shows that she had presented a research paper in seminars sponsored by UGC in February 2012. The petitioner has also produced Ext.R6(j) for having presented the paper during the International seminar organized at the first respondent University in March 2019. The sixth respondent had also presented a research paper at the International Conference conducted by the Centre of Russian Studies, Jawaharlal Nehru University, which is seen from Ext.R6(k). In view of the above exhibits, it is clear that the petitioner satisfied the conditions in Ext.P1 notification, which is also in tune with the UGC Regulations in relation to the exemption from NET. It is also seen that for claiming exemption from the NET, as stated above, was issued by the University. In the absence of any challenge to the said certificate which was issued after verification, the contention of the petitioner that the sixth respondent is not qualified cannot be accepted. It is also to be noted that there are no malafides raised against the selection committee nor are the selection committee members included in their individual capacity. The certificate issued by the University is in order. The qualifications claimed by the sixth respondent are in tune with the stipulations in Ext.P1 notification. Under such circumstances, nothing on record suggests that the sixth respondent was not eligible to participate in the selection process. The contention of the petitioner based on plagiarism in research

work has also attained finality by the Syndicate dropping the further proceedings, which is recorded in the writ petition filed by the sixth

respondent mentioned above

8. It is trite that it would normally be wise and safe for the courts

to leave the decisions of academic matters to the experts, who are more

familiar with problems they face than the courts generally can be. Due

regard should be paid to the opinion expressed by the experts constituting

the selection committee, and in the absence of any illegality or patent

material irregularity in the constitution of the committee or its procedures

vitiating the selection or proved malafides affecting the selection, the

courts will not sit in appeal over the selection so made or venture into

assessing the comparative merits of the candidates.

Under such circumstances, no reliefs are liable to be granted to the

petitioner on the grounds raised in the writ petition. I do not find any merit

in the writ petition. Accordingly, the same is rejected.

# JUDGMENT

The 4th respondent, Dr. Nuaiman K.A was appointed to the post of Assistant Professor (Journalism) in the Department of Journalism and Mass Communication, Calicut University. The petitioner, an aspirant to the very same post, seeks to quash Exhibit P3 minutes of the Syndicate Committee, resolving to appoint the 4th respondent and also Exhibit P4 consequential order passed by the 1st respondent.

# 2. The brief facts are as under:

Applications were invited to the Post of Assistant Professor in Journalism pursuant to Exhibit P1 notification issued by the 3rd respondent. Two vacancies were notified for the post of Assistant Professor (Journalism) and it was mentioned therein that the appointment would be made from the rank list itself. The petitioner being a person eminently qualified for the post put in her application as a candidate in the General Category and took part in the interview. Exhibit P2 is the Rank List published on the website of the University which reveals that she was ranked No.3. According to the petitioner, the 4th respondent is a Muslim Reservation Candidate and he is seen to have been placed as Rank No.1 in Exhibit P2 Rank List. It is contended that as per the reservation roster, the post had to be given to a



General Candidate and not to a Muslim Reservation Candidate. The syndicate meeting held on 30.1.2021 resolved to appoint the 4th respondent against the open (permanent) vacancy based on the recommendations of the Select Committee and Exhibit P3 is the copy of the minutes. The Rank List was published in the web site of the University only on 4.2.2021. However, much prior to the said date, the 4th respondent signed on the attendance register. This would amply demonstrate that the 4th respondent is a predetermined candidate and his appointment was carried out in an objectionable and fraudulent manner. As the petitioner was placed No.3 in the Rank List and as she is an open category candidate, she should have been given appointment instead of the 4th respondent. It is stated that the appointment was not made in a transparent manner and in clear violation of the UGC guidelines and Regulations. Though the petitioner requested the University to furnish her the details of the marklist of the candidates, the same was denied. It is on these allegations that this Writ Petition is filed seeking the following reliefs:

- i. Issue a writ of certiorari or any other appropriate writ, order or direction to quash item 2021.112 dated 31.01.2021 in Exhibit P-3 minutes and Exhibit P-4 order passed by the 1st Respondent University Syndicate and consequential appointment of Respondent No.4 in the post of Assistant Professor (Journalism) in the Department of Journalism and Mass Communication, Calicut University.
- ii. Issue a writ of mandamus or any appropriate writ, order or direction to the

  1st Respondent University to revoke the appointment of Respondent No.4



- in the post of Assistant Professor (Journalism) in the Department of Journalism and Mass Communication, Calicut University.
- iii. Declare that the selection and appointment of Respondent No.4 in the post of Assistant Professor (Journalism) in the Department of Journalism and Mass Communication, Calicut University is null and void.
- 3. A counter affidavit has been filed on behalf of respondents 1 to 3. In the counter affidavit, it is stated that the petitioner was an applicant to the post of Assistant Professor in Journalism pursuant to a notification issued by the University. After a due process of selection, the rank list was published on 31.12.2019. The petitioner herein was included as Serial No.3 in the Rank List. It is contended that a duly constituted Selection Committee conducted the interview and the Rank List was prepared purely based on merit. According to the respondents, as per Section 6 (2) of the University Act, the appointment of Assistant Professor in the Universities is to be made by clubbing together all the teaching departments as one unit for the purpose of applying the rules of reservation and rotation. The turns of filling up the vacancies in the Department of Journalism are 29 and 51A. While the 29th turn is earmarked for Open Competition Candidates, 51A would go to a Physically Challenged person. It is contended that as the 4th respondent was selected on the same standard as applied to General Category and as he stood first in the Rank List, he is bound to be treated as an own merit candidate. It is further stated that the petitioner is not entitled to get appointment, as the 4th respondent, who



is the appointee, is the first rank holder in an open competition and the second vacancy would go to a physically challenged person as per the roster.

- 4. In the counter affidavit filed by the 4th respondent, it is stated that the 4th respondent was appointed as Assistant Professor by Ext.P4 order in the open vacancy. It is the contention of the 4th respondent that he being a candidate who qualifies on merit, he is entitled to occupy the general category even though he belongs to a reservation category. It is further stated that Exts.R4(a) to R4(h) would show the credibility and qualifications of the 4th respondent and the assertions to the contrary made by the petitioner in the writ petition are untenable. The 4th respondent has also stated that pursuant to the decision taken as per Ext.P3 minutes, the 4th respondent was served with an email and it was in the said circumstance that he had joined duty on 01.02.2021.
- 5. I have heard Smt. Simla Prabhakaran, the learned counsel appearing for the petitioner, Sri. P.C. Sasidharan, the learned Standing Counsel appearing for the University and Sri. Amal Kasha, the learned counsel appearing for the 4th respondent.
- 6. The prime contention of the petitioner is that the 4th respondent is a reservation candidate and that he was fraudulently appointed in the open category. From the assertions made in the counter affidavit filed by respondents 1 to 3, it is obvious that the 4th respondent was selected on the



same standard as applied to the general category and he stood first in the General Merit List. It is by now settled without any pale of doubt that if a candidate is entitled to be admitted on the basis of his own merit then such admission should not be counted against the quota reserved for Scheduled Caste or Scheduled Tribe or any other reserved category since that will be against the Constitutional mandate enshrined in Article 16(4).

- 7. In **Indra Sawhney & Ors.** vs. **Union of India & Ors.** (1992 Suppl. (3) Supreme Court Cases 217), the Apex Court held as follows in paragraph 811 of the judgment:-
  - "In this connection it is well to remember that the reservations under Article 16(4) do not operate like a communal reservation. It may well happen that some members belonging to say, Scheduled Castes get selected in the open competition field on the basis of their own merit; they will not be counted against the quota reserved for Scheduled Castes; they will be treated as open competition candidates."
- 8. In **Ritesh R. Sah vs Dr. Y.L. Yamul & Ors** 1996 SCC (3) 253, the Apex Court, following **Indra Sawhney** (supra) reiterated the very same principles.
- 9. It appears that the petitioner has preferred the writ petition on the premise that the 4th respondent was selected not on his own merits but in his status as a muslim reservation candidate. From the records, it has turned out that this is nothing but a misconception on the part of the petitioner. The



substratum of the case set up by the petitioner falls to the ground as a result.

- 10. The next contention advanced by the learned counsel for the petitioner is that the syndicate had not approved the recommendations of the selection committee. I find from Ext.P3 extract of the minutes of the syndicate committee that the Syndicate considered the recommendation of the Selection committee for the post of Assistant Professor (Permanent) in the Department of Journalism and resolved to approve the recommendations of the selection committee and to approve the rank list for the post of Assistant Professor and to appoint the 4th respondent in the post of Assistant Professor. In that view of the matter, the 2nd contention raised by the petitioner also cannot be sustained.
- 11. The 3rd contention advanced by Miss. Simla Prabhakaran is that though the details of appointment of the 4th respondent was uploaded in the website only on 04.02.2021, much prior to that the 4th respondent had signed on the attendance register. As is borne out from Exhibit P4, the 4th respondent was informed that he has been selected for appointment as Assistant Professor in the Department of Journalism and Mass Communication against a permanent open vacancy and by a memo dated 30.1.2021 sent by email, he was asked to report before the registrar within a period of 15 days. The 4th respondent joined duty with effect from the FN of 1.2.2021. There could have been some delay in publishing the rank list in the official website



and in the facts and circumstances, I don't find that the same is a pertinent enough reason to unsettle the appointment granted to the 4th respondent.

In view of the discussion above, I do not think that the petitioner has made out a case for interference. This writ petition is dismissed. No costs.

# Mohammed Nias.C.P., J.

The issue involved in this case, namely, the validity of Section 6(2) of the Calicut University Act, stands covered by our judgment in WA No.755 of 2021 and connected cases dated 5.10.2021. The learned counsel for the petitioner, however drew our attention to the judgment of the Supreme Court in **Chebrolu Leela Prasad Rao and Ors. v. State of A.P. And Ors.** ( Civil Appeal No.3609 and 7040 of 2002) for the proposition that providing hundred percent reservation to a post is not permissible. We do not think that the said proposition admits of any doubt. The judgment of the Supreme Court referred above does not lend any support to the contentions of the petitioner herein. All the contentions raised in the above writ petition are considered and found against the petitioner in the judgment dated 5.10.2021 in WA No.755 of 2021 and connected cases.

In the light of the above judgment, this writ petition is dismissed.

# JUDGMENT

The petitioner aspires to be appointed as a Professor in the Department of Mathematics in the 2<sup>nd</sup> respondent - University of Calicut. He says that he is a Ph.D holder having every other qualification and that he thus responded to Ext.P5 notification issued by University, by making Ext.P6 application through online. He says that he was interviewed by the Selection Committee on 18.01.2022, but when Ext.P9 Rank List was published, he found, to his dismay, that he was excluded. He says that, therefore, he has preferred Ext.P24 representation before the Vice Chancellor of the University, but alleges that no action has been taken thereon until now.

2. Sri.Dipu.R - learned counsel for the petitioner, further submitted that his client

has been reliably informed that the sole reason why he has been excluded from Ext.P9 Rank List is that, pending the selection process, the University came out with Ext.P14 fresh selection criteria for recruitment of Associate Professor and Professors in their services. He argued that the rigour of Ext.P14 cannot be used against his client since it operates contrary to the applicable Regulations of the University Grants Commission (UGC Regulations) and because such Regulations have already been adopted by the University, through Exts.P11 and P12 orders. He argued that, therefore, refusal of the University to include his client in Ext.P9 Rank List and appoint him to the available post of Professor in the Department of Mathematics is illegal and unlawful.

3. In response, however,
Sri.P.C.Sasidharan - learned Standing Counsel

the Calicut University, submitted that issued taking note of the Ext.P14 has been relevant requirements under the applicable UGC Regulations. He submitted that, in any event, going by the UGC Regulations, his client has the right and competence to fix necessary criteria for the purpose of interview to the post of Associate Professor/Professor; and that has thus been issued to ensure Ext.P14 highest standards among the candidates available. He then added that the petitioner cannot maintain this writ petition because learned Full Bench of this Court has already declared in Unnikrishnan Nair. G.S and others v. State of Kerala and others [ILR 2019(1) Kerala 775] that mere inclusion in the Rank List will inure to him any vested right to appointed and that it is upto the employer to decide in what manner it has to be done.

thus prayed that this writ petition be dismissed.

- 4. Pertinently, Sri.S.Krishnamoorthy learned Standing Counsel for the UGC, submitted that Ext.P14 does not go counter or contra to the applicable UGC Regulations and that Clause 6.1 of the "UGC Regulations, 2018" leave it to the University concerned to fix their own criteria for the purpose of interview. He added that, therefore, his client does not stand in the way of appropriate orders being issued by this Court.
- 5. When I consider and evaluate the afore rival contentions, it is indubitable that, on one hand, the petitioner seeks to be included in Ext.P9 Rank List; while, on the other, the University says that he does not satisfy the criteria prescribed under Ext.P14.
  - 6. However, it must be borne in mind that

Ext.P14 was brought into effect much after the petitioner made his application online, pursuant to Ext.P5 notification. Since the UGC says that Ext.P14 is not their Regulations, I am of the view that petitioner and other candidates who have applied, must be given an opportunity of satisfying the new criteria under the said notification.

In the afore circumstances, I dispose of this writ petition with the following directions:

a) The University will offer the petitioner and every other candidate, who have applied under Ext.P5 notification, to offer additional inputs with respect to their satisfaction of the conditions and qualifications under Ext.P14, within a period of two weeks from the date of receipt of a copy of this judgment.

- b) The petitioner and other candidates will be at liberty to offer their inputs as per Ext.P14 criteria to the University within the periods specified by them in terms of direction (a) above.
- (c) On the petitioner and other candidates furnishing their additional inputs as afore, same will be considered by the University and a decision taken on their inclusion in the Rank List in terms of law, after affording them an opportunity of being heard. This shall be done, as expeditiously as is possible, but not later than one month from the date on which the additional inputs are furnished by the petitioner and others.
- d) Needless to say, on the afore exercise being completed and the petitioner or any other person being found eligible to be included in the Rank List, necessary action for the said

# JUDGMENT

Dated this the 19th day of March, 2025

The petitioner, who is now working as Professor in the Department of Mathematics, Government Engineering College, Thrissur, has filed this writ petition seeking to set aside Ext.P10 and to direct the respondents to consider the claim and interview the petitioner on the basis of Ext.P2 application submitted by the petitioner for the post of Professor in Mathematics as per Clause 4.1 (III) A (ii) of UGC Regulations, 2018 and Ext.P1 notification, without delay.

2. The petitioner states that the respondents have invited application for selection and appointment to the post of



Professors in various Departments in the University as per Ext.P1 notification. As the petitioner is qualified for the post of Professor in Mathematics, the petitioner submitted Ext.P2 application.

- 3. The petitioner learnt that the interview for the post of Professor in Mathematics was held on 18.01.2022 and no candidates are ranked. According to the petitioner, the petitioner is fully qualified as per UGC Regulations, 2018 and as per Ext.P1 notification. He is entitled to be called for the interview and to get his candidature considered for appointment to the post of Professor in Mathematics.
- 4. The petitioner, therefore, submitted a representation to the 2<sup>nd</sup> respondent. The petitioner filed W.P.(C) No.27065 of 2023. This Court directed the matter to be considered, as per Ext.P9 judgment. The respondents, however, have rejected the representation of the petitioner as per Ext.P10 order. In Ext.P10



order, the Deputy Registrar has stated that the petitioner's application for appointment to the post of Professor in the Department of Mathematics stands rejected for want of the mandatory qualifications as stipulated by the UGC.

- 5. Counsel for the petitioner relied on Ext.P1 notification and stated that the petitioner has all the requisite qualifications prescribed in Ext.P1. Ext.P1 states that a minimum of ten years of teaching experience in University / College as Assistant Professor / Associate Professor / Professor and / or research experience at equivalent level at the University / National Level Institutions with evidence of having successfully guided doctoral candidate.
- 6. Counsel for the petitioner submitted that the petitioner has more than ten years teaching experience as is evident from Ext.P2 and for persons having more than ten years teaching experience, research experience equivalent level need



not be insisted. The words "and / or" contained in Clause 1 (A)(ii) is to be treated as "or" only and any other meaning will defeat the very purpose of the rules and will create an awkward situation.

- 7. The eligibility conditions as prescribed in Ext.P1 is in tune with Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education Regulations, 2018 of the UGC. As the petitioner satisfies the eligibility conditions and essential qualifications as prescribed in Ext.P1, the petitioner's candidature is liable to be considered for selection and appointment to the post of Professor, urged the Counsel for the petitioner.
- 8. Standing Counsel entered appearance on behalf of the respondents and resisted the writ petition. On behalf of the respondents, the Standing Counsel submitted that "evidence of



having successfully guided doctoral candidate" is one of the mandatory qualifications for the post. The petitioner cannot be considered to have required qualification as per notification as there is no evidence of successfully guiding doctoral candidates. In the selection process, only one candidate was found to have the requisite qualifications. That candidate was interviewed by the Selection Committee. The single candidate could not score the minimum marks required as per the interview criteria. Therefore, the single candidate was not ranked.

9. On behalf of the respondents, it is submitted that the words "and / or" in the Clause is not meant for research experience only. A candidate should possess either teaching experience of ten years or research experience of ten years at an equivalent level or a total of ten years of experience in teaching and research combined together. But, even though the



petitioner is having research experience and teaching experience, still he should have the further qualification of successfully guiding doctoral candidates.

- 10. I have heard the learned Counsel for the petitioner and the learned Standing Counsel representing the respondents.
- 11. The petitioner responded to Ext.P1 notification and applied for selection to the post of Professor in Mathematics. Ext.P2 is the copy of application submitted by the petitioner. Ext.P2 would indicate that the petitioner has three years and zero months and 19 days of teaching experience in Government Engineering College, Sreekrishnapuram and 12 years, 7 months and 16 days teaching experience in Government Engineering College, Thrissur.
- 12. Ext.P1 notification gives essential qualifications for candidates. The essential qualifications read as follows:-

# **Essential qualifications**:

1) For the Disciplines of Arts, Commerce, Humanities, Social Sciences, Sciences, Languages, Library Science and Journalism & Mass Communication.

Eligibility (A or B)

### Α.

- i) An eminent scholar having a Ph.D Degree in the concerned/allied/relevant discipline and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer reviewed or UGC listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2 of UGC Regulations, 2018.
- ii) A minimum of ten years of teaching experience in University/College as Assistant Professor/Associate Professor/Professor **and/or** research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

13. Ext.P11 is the UGC Regulations on Minimum Qualification for Appointment of Teachers and other Academic Staff in the Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018. Regulation 4.1(III) of the Regulations, 2018 reads as follows:

# III. Professor: Eligibility (A or B):

Α.

- i) An eminent scholar having a Ph.D. Degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2.
- ii) A minimum of ten years of teaching experience in University/College as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

B. An outstanding professional, having Ph.D.Degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge concerned/allied/relevant discipline, supported by

documentary evidence provided he/she ten years' experience.

- 14. Regulation 4.1 (III) would show that the University has practically adopted the qualification prescribed by the UGC. The contention of the petitioner is that a candidate need either a minimum of ten years of teaching experience in University / College as an Assistant Professor / Associate Professor / Professor and / or research experience at equivalent level at the University / National Level Institutions with evidence of having successfully guided doctoral candidate.
- 15. According to the petitioner, the term "and / or" appearing above, is evidently a mistake and the term should be treated to mean as "or", because any other meaning attributed to the qualification part would result in an anomaly. In other words, the argument of the petitioner is that if persons having minimum ten years of teaching experience in University /

College as Assistant Professor / Associate Professor / Professor, then such candidates are entitled to apply for the post even if the candidates do not have research experience at an equivalent level at the Universities / National Level Institutions with evidence of having successfully guided doctoral candidates.

16. Going through Exts.P1 and P11, I find that the proposition advanced by the petitioner cannot be accepted. It is for the reason that the rationale behind prescribing such qualifications is that, the post being of a Professor in the University, experience in research guidance cannot alone be taken as a desirable qualification. Apart from teaching experience, experience in guiding research scholars is important in the matter of discharge the duties of a Professor. It is for that reason that the UGC, as well as the respondents, insisted that for appointment as a Professor, there should be

evidence of having successfully guided doctoral candidates.

- 17. It is further to be noted that the experience in successfully guiding doctoral candidates is a distinct requirement unconnected with the experience in teaching or experience in research. Either way, whether a candidate is experienced in teaching or whether a candidate is experienced in research, such candidates should have a minimum experience in guiding doctoral candidates, the post held being that of a Professor.
- 18. In the circumstances, I find that the essential qualifications for appointment to the post of Professor prescribed in Exts.P1 and P11 should be taken as one insisting for successfully guiding doctoral candidates, which is applicable to both categories, namely, candidates having teaching experience and candidates having research experience. Admittedly, the petitioner does not have evidence of having

successfully guiding doctoral candidates. Therefore, the respondents were justified in not considering the candidature of the petitioner.

The writ petition fails and it is therefore dismissed.

## **JUDGMENT**

The petitioner claims appointment on the basis of a rank list prepared as per Ext.P2. The contention is that there was a vacancy that arose on account of suspension of a teacher who was appointed from the same ranked list. Even going by the case of the petitioner, the rank list expired on 04.02.2022. The claim of a vacancy to the post based on the suspension of a teacher cannot be accepted as the suspension period of an employee cannot be treated as a substantive vacancy. Further, the rank list expired on 04.02.2022. Given the above facts, there is no merit in the contentions. The belated claim put forth is hit by laches as well.

Accordingly, the writ petition is dismissed.
