NOTIFICATION

G. O. (Ms.) No. 12/2013/PAD. Dated, Thiruvananthapuram, 25th November, 2013.

**S. R. O. No. 924/2013.**—In exercise of the powers conferred by section 10 of the Payment of Salaries and Allowances Act, 1951 (XIV of 1951), read with section 8B thereof, the Government of Kerala hereby make the following rules to amend the Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013 issued under G. O. (Ms.) No. 3/2013/PAD dated 28th February, 2013 and published as S.R.O. No. 158/2013 in the Kerala Gazette Extraordinary No. 679 dated 5th March, 2013, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Members of the Kerala Legislative Assembly (House Building Advance) Amendment Rules, 2013.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013,—

- (1) sub-rule (3) of rule 6 shall be omitted;
- (2) in rule 7,—
  - (i) for sub-rule (1), the following shall be substituted, namely:—
 

“(1) The repayment of advance by the borrower shall be determined by the sanctioning authority in the manner specified under these rules and will be indicated in the order of sanctioning the loan subject to the condition that the recovery towards principal and interest together shall not exceed 120 monthly instalments;
  - (ii) in sub-rule (3), for the figure ‘52’, the figure ‘100’ shall be substituted;
- (3) in sub-rule (2) of rule 8, for the figure ‘8’, the figure ‘20’ shall be substituted.

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

For carrying out the provisions of section 8B of the Payment of Salaries and Allowances Act, 1951 (XIV of 1951), Government have framed the Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013 vide G. O. (Ms.) No. 3/2013/PAD dated 28th February, 2013 and published as S.R.O. No. 158/2013 in the Kerala Gazette Extraordinary No. 679 dated 5th March, 2013. In view of urgency, the above said notification was issued without getting ratification from the Subject Committee. The Subject Committee on scrutiny of the said notification, recommended certain amendments to the Rules. Hence the Government have decided to amend the said Rules accordingly.

The notification is intended to achieve the above object.
