NOTIFICATION

G. O. (Ms.) No. 8/2014/PAD. Dated, Thiruvananthapuram, 28th October, 2014.

S. R. O. No. 689/2014.—In exercise of the powers conferred by section 10 of the Payment of Salaries and Allowances Act, 1951 (XIV of 1951), read with section 8B thereof, the Government of Kerala hereby makes the following rules further to amend the Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013 issued under G. O. (Ms.) No. 3/2013/PAD dated 28th February, 2013 and published as S. R. O. No. 158/2013 in the Kerala Gazette Extraordinary No. 679 dated 5th March, 2013, namely:—

**RULES**

1. *Short title and commencement.*—(1) These rules may be called the **Members of the Kerala Legislative Assembly (House Building Advance) Amendment Rules, 2014.**

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the **Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013,—**

(1) in rule 7,—

(i) in sub-rule (1) for the figure “120”, the words “one hundred and eighty” shall be substituted;

(ii) in sub-rule (3) for the figure “100”, the words “one hundred and fifty” shall be substituted;

(2) in sub-rule (2) of rule 8, for the figure “20”, the word “thirty” shall be substituted.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The **Members of the Kerala Legislative Assembly (House Building Advance) Rules, 2013** was issued under G. O. (Ms.) No. 3/2013/PAD dated 28th February, 2013 and published as S.R.O. No. 158/2013 in the Kerala Gazette Extraordinary No. 679 dated 5th March, 2013. On the recommendation of the Subject Committee the said Rules, were amended vide G. O. (Ms.) No. 12/2013/PAD dated 25th November, 2013 and published as S. R. O. No. 924/2013 in the Kerala Gazette Extraordinary No. 3318 dated 27th November, 2013. The Thirteenth Kerala Legislative Assembly in its Tenth Session discussed a notice on amendment to the **Members of the Kerala Legislative Assembly (House Building Advance) Rules**, and recommended certain amendments to the said Rules. Hence Government have decided to amend the said Rules.

The notification is intended to achieve the above object.
