REPORT

This report deals with the Action Taken by Government on the recommendations contained in the One Hundred and Fifty Seventh Report of the Committee on Public Accounts (2008-11).

One Hundred and Fifty Seventh Report of the Committee on Public Accounts (2008-11) was presented to the House on 23rd February, 2011. The Report contained 15 recommendations relating to Social Justice Department. The Report was forwarded to the Government on 1st March, 2011 to furnish statement of Action Taken on the recommendations contained in the report and final report received on 29th April, 2013.

The Committee examined the statements of Action Taken received from Government at its meeting held on 27-8-2013 and decided not to pursue further action on the recommendations in the light of the replies furnished by Government. Such recommendations and Government replies are incorporated in this report.

SOCIAL JUSTICE DEPARTMENT

Recommendation

(Sl. No. 1, Para No. 57)

The Integrated Child Development Services Scheme launched in 1975 is a Centrally Sponsored Scheme aimed at the exhaustive development of children up to six years of age, adolescent girls and pregnant and lactating mothers by providing a package of services comprising supplementary nutrition, immunisation, health check-up, referral services, non formal pre-school education and health and nutrition education. Even though there is a well devised Government machinery for the implementation of the scheme in the State under Social Welfare Department, the Committee is at a loss to find that many of the objectives could not be fulfilled even after several decades due to various reasons. It is a stark reality that even the entire eligible population could not be brought under its purview.

Action Taken

In Kerala, there are 33115 Anganwadi Centres sanctioned by Government of India for providing services such as supplementary nutrition, growth monitoring, health check-up, nutrition and health education, referral services, immunisation, non formal pre-school education, etc. Children below 6 years and pregnant and lactating mothers are the beneficiaries under the scheme. The ICDS manual specified the criteria for selection of beneficiaries such as 1575/2014.

scheduled caste, scheduled tribe, disabled etc. Based on the direction of Hon'ble Supreme Court in WP(c) No. 196/2001 dated 13-12-2006. Government of India withdrew the selection criteria and issued orders to the effect that all children below 6 years, pregnant and lactating mothers should be provided supplementary nutrition. It is a fact that in Kerala, pre-school education sector, there is strong presence of private agencies. Moreover, PTA in almost all schools are also providing the pre-school education. Due to the strong presence of private sector, the pre-school beneficiaries under ICDS has been reduced marginally. However, State Government have initiated various steps to improve the infrastructural facilities in Anganwadi Centres and providing play materials and training the functionaries in order to attract more children in pre-school.

Government had also taken initiative for strict periodic annual survey and enlist all the beneficiaries in this scheme. Progress of the coverage is being monitored during the monthly review meeting and directions have been given to the Child Development Project Officers to place the issue before local panchayats to provide Supplementary Nutrition to cover all the beneficiaries. In tribal area Government have issued a special direction for providing take home ration to all required beneficiaries in order to ensure the coverage.

Moreover, Government have also decided to construct a Model Anganwadi Centre in each Assembly Constituency with facilities such as Adolescent Club, Immunisation facility, Reading room for old persons, Common facility centres etc.

Steps have also been taken to revise the 'Thematic Approach' a pre-school curriculum being adopted in Anganwadi Centres. There is also a plan to integrate anganwadi curriculum with the formal pre-school curriculum.

Recommendation

(Sl. No. 2, Para No. 58)

Being a centrally Sponsored Scheme, Government of India is responsible for the programme planning and infrastructure funding and the State Government for programme implementation and supplementary nutrition. State Government should have strived to make optimum use of the Central Government funds received under various components but instead the Committee finds that there was lack of enthusiasm in fulfilling even the basic objectives of the scheme. The Social Welfare Department could not commence operation of 95 additional ICDS Projects sanctioned by Government of India during the third phase for want of necessary clearance from Finance Department. From the facts submitted by

the Secretary, Finance (Expenditure) Department, it is obvious that the Social Welfare Department had shirked from its responsibility of obtaining necessary clearance from Finance Department in time. The Committee is utterly disappointed at the reckless manner in which Social Welfare Department had handled matters and insists to be informed of the precise date on which the third phase of the scheme was sanctioned by the Central Government, the date on which proposal for clearance for the projects was forwarded to Finance Department, whether clearance has since been obtained and if so when and the up to date position of the sanctioned projects.

Action Taken

Government of India have conveyed the sanction of additional 95 ICDS Projects, 871 AWCs and 129 Mini Anganwadi Centers under 3rd phase of expansions of ICDS Scheme vide letter no.14-2/2008/CD-I dated 11-12-2008. The Director, Social Welfare, had submitted proposals for the same as per letter No. ICDS/B1-15303/07 dated 14-1-2009 and Government has sought for additional information in the matter from the Director, Social Welfare. After getting the additional information, the opinion of the Planning and Economic Affairs Department, Finance Department and Local Self Government Department had been called for since there was additional financial commitment. Accordingly the proposal was finally forwarded to Finance Department on 25-9-2009 and clearance received vide U.O. Note No. 49845/WW1/10/Fin. dated 12-7-2010. Administrative Sanction for operationalising the 95 ICDS Projects was issued vide G.O.(Ms.) No. 46/10/SWD dated 31-7-2010 and the functioning of all the 95 projects has also been started.

Recommendation

(Sl. No. 3, Para No. 59)

The Committee perceives that the Anganwadi Workers were required to conduct house hold survey of the respective areas, obtain the details of each household and enter it in the AWC Survey Register meant for the purpose which was to be updated each month. Also, an intensive revision of the Register is to be done by conducting a door to door survey once in five years. This is to be treated as an authentic basic data for the effective implementation of the scheme. The Committee is disturbed at the Audit finding that the Anganwadi Survey Registers were not maintained properly in any of the Anganwadi Centres test checked. The Secretary, Social Welfare Department had substantiated that the Anganwadi Workers and Helpers are mandatorily entrusted with various survey works and other duties by the Panchayats for a meagre remuneration and hence it has become extremely improbable for them to attend

to household surveys and even the chores related to Anganwadis. Sensing the seriousness of the situation, the committee recommends to spare the Anganwadi Workers and Helpers from survey works and such other duties assigned to them by Local Self Government Institutions. The Social Welfare Department should ensure that the Registers maintained in the Anganwadi Centres contain all the vital information which is a prerequisite for the proper planning and implementation of the scheme.

Action Taken

Social Welfare Department have provided printed survey registers and directed to update the survey. A special drive is also planned to ensure the correct annul survey. As regards entrusting other duties of Anganwadi Workers and Helpers Government of India have issued strict guidelines for the utilisation of entire services of Anganwadi Workers and Anganwadi Helpers and also not to entrust any other work other than the ICDS to the Anganwadi Workers and Anganwadi Helpers. Accordingly, necessary direction have been given to the Anganwadi Workers and Helpers, ICDS Supervisors and the Child Development Project Officers for taking necessary steps for the effective delivery of the ICDS Services viz., Supplementary Nutrition, Growth monitoring, Nutrition and Health Education, Immunisation, Referral and pre-school education and extending the ICDS services to every child under the age of 6, all pregnant women, lactating mothers and all adolescent girls and thereby achieving the objectives of ICDS since it is inappropriate to entrust additional duties to the AWWs/AWHs for the rest of the time after performing the existing role and responsibilities envisaged under the ICDS. Government have therefore requested the Director, Census and the State Election Commission to spare Anganwadi employees from the work connected with census. election etc.

Recommendation

(Sl. No. 4, Para No. 60)

The Committee is dissatisfied at the manner in which Social Welfare Department had dealt with the various components of the scheme. Even though Government of India was providing financial assistance for Kishori Shakti Yojana, from 2002-03 onwards, it remained unutilised with State Government until 2006, for want of administrative sanction for its implementation. The Department could neither explain the reasons for the inordinate delay in issuing administrative sanction, at the time of audit paragraph examination nor put forth any substantial grounds for the same in the additional information furnished subsequently. Despite the fact that the unspent balance of ₹ 1.78 crore had been revalidated and utilised in the subsequent year, the deliberate silence of

the Department towards the Committee's query could not be tolerated at any cost. This reticence is construed as a disgrace to the Committee and insists that the desired reply be furnished within no time.

Action Taken

As a new Centrally Sponsored Scheme launched in 2002-03 it took certain administrative delay, not deliberate, in pursuing initial formalities for implementing the KSY. But then after overcoming the delay, since 2006-07 Government have been implementing the scheme without making any lapses for utilising the allotted fund. Moreover, Government also utilised the unspent balance of the fund which occurred due to the non-implementation of the scheme has been revalidated and utilised in the subsequent year.

Recommendation

(Sl. No. 5, Para No. 61)

It is awful to note that even though approximately ₹ 150 crore had been released as Government of India assistance to Local Self Government Institutions (LSGIs) for implementing Supplementary Nutrition Programme in the State, utilisation certificates were yet to be submitted by many of the local bodies owing to which the monitoring of its effective utilisation has become unfeasible. The Committee recommends that necessary directions be issued to LSGIs to submit the utilisation certificates without any more delay.

Action Taken

Local Self Government Department has been requested to issue necessary directions to LSGIs to submit the utilisation certificate in respect of Supplementary Nutrition Programme regularly without delay (copy enclosed-Annexure I).

Recommendation

(Sl. No. 6, Para No. 62)

The Committee from the additional information submitted by the department, comprehends that out of the unspent balance of ₹ 8,77,41,238 as on 8-9-2008 under the Nutrition Programme for Adolescent girls, ₹ 501.58 lakh had been revalidated by Government of India for utilisation during 2008-09 and that ₹ 292.31 lakh had been put to use the same year. Since the Central Government was contemplating a new scheme for adolescent girls the following year, it has sought for the details of the unspent balance of ₹ 209.27 lakh retained with the State Government. The Committee seeks to be informed

whether the data as desired by Government of India has been furnished and if so the details be furnished to the Committee at the earliest.

Action Taken.

Data have been furnished to Government of India vide letter No. ICDS/B3-3346/01 dated 20-6-2009 (Copy enclosed-Annexure II) by the Director, Social Welfare.

Recommendation

(Sl. No. 7, Para No. 63)

The Committee is disturbed to find that the World Bank allocation of ₹ 30 crore towards construction of Anganwadi buildings could not be exhausted for the intended purpose owing to the difficulty in identifying suitable land. The Committee is aware of the fact that many Anganwadis did not have own buildings but it equally realizes the predicament of the State Government in selecting sites for construction. Therefore the Committee recommends that puramboke land and any space lying idle in Government buildings should invariably be set apart for Anganwadi Centres.

Action Taken

Government as per G.O.(Rt.) No. 578/2009/SWD dated 9-12-2009 have constituted a Sub committee consisting of the following members for identification of land and buildings for the Anganwadis:

- 1. Principal Secretary, Local Self Government Department-Chairman.
 - 2. Secretary to Government, General Education Department-Member.
 - 3. Commissioner of Rural Development-Member.
 - 4. Secretary to Government, Social Welfare Department-Convenor.

The Committee shall look into the following:-

- (a) Whether a minimum extent of 5 cents of land can be identified by all department for construction of Anganwadi Centres.
- (b) Whether Anganwadi Centres can be permitted to be set-up in the premises of Government Schools in lieu of Nursery/K.G. classes where sufficient land and building are available.
- (c) Whether the construction of buildings and toilets and provision of drinking water facilities can be taken up by converging the various schemes of the Government.

The proposal in this regard submitted by the Director, Social Welfare, is being examined by the Sub committee.

Recommendation

(Sl. No. 8, Para No. 64)

The Committee discerns that World Bank had approved construction of 40 Anganwadi Centres completely destroyed by Tsunami at a cost of ₹ 1.25 lakh per building to be shared by World Bank and State Government in the ratio 75:25 and had released ₹ 30 lakh in March 2005 for the said purpose. The Committee is vexed at the revealation of the Secretary, Social Welfare Department that works in respect of 13 buildings were yet to commence and those in the worst affected Arattupuzha area could not be culminated on account of the indiscreetness of the respective panchayat. Deprecating such an apparent imbecility, the Committee requires the department to intimate the up-to-date position of all the pending projects.

Action Taken

The details of Anganwadi Building Construction aided by World Bank is show below:—

Recommendation

(Sl. No. 9, Para No. 65)

The Committee is annoyed to note that even though the department has provided the split up of the number of pre-school kits purchased from 2005-06 to 2008-09 and the amount expended for the same, the department is keeping a

measured silence as to whether the purchased kits were distributed to the beneficiaries. The Committee calls upon the department to intimate whether the purchased pre-school kits have been supplied to the incumbents and if not, the reasons for failure and the action taken in this respect. The Committee recommends that medicine kits and pre-school kits should be provided to all the Anganwadi Centres every year.

Action Taken

The district wise details relating to the number of pre-school kits procured and distributed during the period from 2005-06 to 2008-09 is attached as Annexure III. The Director, Social Justice has been directed to ensure that medicine kits and pre-school kits purchased are provided timely to all the Anganwadi Centres every year in time (copy enclosed) Annexure IV.

Recommendation

(Sl. No. 10, Para No. 66)

The Committee is aware of the fact that the retirement age of Anganwadi Workers and Helpers could be confined to 60 years only after the implementation of the proposed pension scheme. Even though vide G.O.(Ms.) No. 31/2009/SW dated 7-8-2009, Government had introduced pension plan for them, it could not be put into effect due to a stay order by the Hon'ble High Court on 25-8-2009 in WP(C) 23532 of 2009. Since the competency of the Anganwadi Worker is a vital factor in the success of the ICDS services, it is utmost essential that the upper age limit is strictly adhered to. Hence the Committee insists to intimate whether the stay order has since been vacated and the latest position of the implementation of the pension scheme for the Anganwadi Workers and Helpers.

Action Taken

The stay order of the Honourable Court has been vacated. The Hon'ble High Court in its judgment dated 26-7-2010 have dismissed the petition and held that the retirement age of 60 years cannot be said to illegal or unconstitutional warranting judicial review.

Now Government as per G.O.(Ms.) No. 33/12/SWD dated 31-5-2012 have enhanced the retirement age of Anganwadi Workers and Helpers to 62 years. Proposal for enhancing the pension amount of Anganwadi Workers and Helpers from ₹ 500 to ₹ 750 and ₹ 300 to ₹ 550 respectively is under the consideration of Government.

Recommendation

(Sl. No. 11, Para No. 67)

The Committee is discontented to observe that albeit Government of India's request in October 2006 to create a separate cadre for ICDS, the State Government has not responded positively towards the same. Since the Committee assumes that it would be advantageous for establishing a cadre of professionals in the field of women/child welfare and would entail greater control and supervision over the field staff, the Committee recommends to create a separate cadre for ICDS with immediate effect.

Action Taken

As part of revising the staff pattern in the State/District level ICDS cell under the Social Welfare Department, Government of India have issued instructions for creating new posts. Government of Kerala as per G.O.(Ms.) No. 27/12/SWD dated 11-5-2012 have accorded sanction for creating the following posts in this regard.

- 1. State Project Director 1 post
- 2. Lower Division Clerk 7 posts

Moreover, 3 Junior Superintendent posts and 11 Head Accountant posts in the District ICDS Cell have been upgraded and renamed as Senior Superintendent. However, there is no separate cadre for ICDS in the State at present as the posts under ICDS are integrated with other posts in the department. Government are actively considering the issue of bifurcating the Social Welfare Department with separate units for Women and Child Welfare and it has been decided in principle to form an Expert Committee for this purpose at the earliest. The intention behind it is to ensure greater care in the field of women/child welfare. Once the department is bifurcated it will be possible to exercise greater control and supervision of the field staff under ICDS even without a separate cadre.

Recommendation

(Sl. No. 12, Para No. 68)

It is rather inequitable to notice that the State Project management Unit which assisted Phase III of the ICDS Project in the State, is still functioning even after the termination of the same on 31st March, 2006. The Committee opines that the retention of the staff after the closure of the project is illegal and hence urges that the staff should be deployed for other works in connection with ICDS Projects.

Action Taken

Government as per G.O.(Rt.)No.280/12/SWD dated 11-6-2012 have issued orders for redeploying the following staff in the State Project Management Unit to State ICDS Cell.

- 1. Joint Project Co-ordinator 1
- 2. Accounts Officer 1
- 3. L. D. Clerk 4

Recommendation

(Sl. No. 13, Para No. 69)

The Committee perceives that there is heavy shortfall in the inspection of Anganwadi Centres by Programme Officers/CDPOs/Supervisors as laid down in the guidelines issued by State ICDS Cell. Since the dearth in inspection is severely affecting the effective implementation of the various schemes of ICDS, the Committee insists that necessary action should be taken to ensure that the Programme Officers/CDPO/Supervisors are conducting the prescribed visits to Anganwadi Centres. Steps should be taken to convene the State/District/Block/Municipal/Corporation/Panchayath level Monitoring Committees for the proper monitoring and review of the implementation of ICDS Programmes.

Action Taken

Strict instructions have been issued with regard to the strengthening of the visit of the Programme Officers, CDPOs, Supervisors in Anganwadis. Instructions have also been issued to follow the norms strictly.

As regards to monitoring from State level to Anganwadi level, Government of India have issued revised guidelines as per letter No.16-8/10-ME dated 31-3-2011 and the proposal for reconstituting the ICDS monitoring Committee is under the consideration of Government.

Recommendation

(Sl. No. 14, Para No. 70)

The Committee is surprised to notice that the incumbent to the post of the Director of Social Welfare was changed 11 times during 2002-07. Since it would adversely affect the functioning of the scheme, the Committee recommends that a person appointed as Director should be allowed to continue in office at least for a period of three years.

Action Taken

Director of the Department are posted from IAS cadre. Their transfer and postings is done in General Administration Department in Government and that department has been requested to take necessary action in the matter.

Recommendation

(Sl. No. 15, Para No. 71)

The Committee also recommends that the Internal Audit Wing which was set-up very recently in the Social Welfare Directorate should be strengthened by posting necessary competent staff to that wing.

Action Taken

Government as per G.O.(Ms.) No. 70/2010/SWD dated 24-9-2010 have issued directions to start the functioning of the Audit Cell in the Social Welfare Directorate by redeployment.

I may invite your kind attention to the latter under reference. Government of India conveyed sanction for the continued implementation of the Scheme Nutrition Programme for Adolescent Girls in the Districts of Phinkkad and Malappuram during the year 2008-09 vide reference 1st cited. As per reference 2st cited a sum of Rs.501.58 lakhs as unspent balance available with this State as on 1.4.2008 under NPAG had revalidated for implementation of NPAG in 2008-09.

The entire quantity of food grains allocated for the year 2008-09 (Palakkad-1734.79 MTs of rice Malappuram-2583.10 MTs of rice Total-1734.79+2683.10 = 4417.89 MTs) was fully lifted and distributed among the beneficiaries. An amount of Rs.292.31 lakhs was incurred towards implementing NPAG Scheme during the year 2008-09. The utilization certificate and Armual Progress report for the year 2008-09 has already been submitted to Government of India vide reference 4th cited.

An amount of Rs.209.27 lakhs remains as unspent balance out of Rs. 501.58 lakhs which was revalidated for the implementation of NPAG during 2008-09

Therefore it is requested that sanction may be accorded for the continuation of the NPAG during 2009-10 and revalidation of Rs. 209.27 /- lakks remains unspent balance of the previous year available with this state.....
