## THE PAYMENT OF SALARIES AND ALLOWANCES (AMENDMENT) BILL, 2014

#### BILL

further to amend the Payment of Salaries and Allowances Act, 1951.

*Preamble.*—Whereas, it is expedient further to amend the Payment of Salaries and Allowances Act, 1951 for the purpose hereinafter appearing;

BE it enacted in the Sixty-fifth Year of the Republic of India as follows:—

- 1. Short title and commencement.—(1) This Act may be called the Payment of Salaries and Allowances (Amendment) Act, 2014.
  - (2) It shall come into force at once.
- 2. Amendment of section 8A.—In the Payment of Salaries and Allowances Act, 1951 (XIV of 1951), in sub-section (5B) of section 8A, for the words "seven thousand and five hundred" the words "twelve thousand and five hundred" shall be substituted.
