REPORT

The Eightieth Report of the Committee on Public Undertakings (2004-2006) on Kerala State Construction Corporation Ltd. based on the Report of the Comptroller and Auditor General of India for the year ended 31st March 1998 (Commercial) was presented to the House on 10-3-2005.

The Report contained only one recommendation and the Government furnished reply to the recommendation. The Committee (2006-08) considered the reply received from Government at its meeting held on 5-12-2007.

Implementation of VRS in KSCC Ltd. is under active consideration of Government. It is expected to reduce the strength of employees by 50%. In order to deploy surplus non-technical unproductive labour force, KSCC had already entered into the field of toll collection and now tied up with Roads & Bridges Development Corporation of Kerala Ltd. (RBDC) for entrustment of more toll collection enters. The KSCC Ltd. has already entered into the field of providing consultancy service to the construction industry.
