ORDER

In the meeting held on 18.12.2020 , it was decided to call for a tender for securing competitive bids for procuring the services of a helicopter on wet lease basis, consequent to the termination of one year of service contract with M/s. Pawan Hans Ltd. As instructed by Government, the State Police Chief, vide letter read as 2nd paper above, furnished revised draft tender document for inviting bids. As per G.O

read as 3rd paper above, the Government approved the draft tender notice submitted by the State Police Chief and authorized the State Police Chief to proceed with National Competitive Bidding to procure helicopter service on wet lease basis, subject to the following conditions:-

a)The tender documents shall be uploaded in E-Tender website of the Government also.

b)The State Police Chief shall furnish the bids with suggestions to Government, with due recommendation of the Technical Committee to be constituted as per the Stores Purchase Manual.

2) Accordingly e-tenders were invited by the State Police Chief for the procurement of helicopter services on wet lease basis, complying with all formalities vide E-Tender read as 4th paper above.

3) Three firms viz. M/s Chipsan Aviation Pvt. Limited, New Delhi, M/s OSS Air Management Pvt. Limited, Mumbai and M/s Heligo Charters Pvt. Limited, Mumbai offered bids against the E-Tender. Subsequently, the Technical Committee, constituted under the Chairmanship of Additional Director General of Police (Police Head Quarters) for proper evaluation of the e-tender documents vide G.O read as 5th paper above, conducted technical evaluation on 06.12.2021 and assessed that all the three bidders satisfactorily qualified the technical evaluation and met all the stipulated specifications in this regard and recommended for further process. Consequently, the Financial Bid Opening Committee constituted by the State Police Chief met on 14.12.2021 and opened the financial bids in the presence of the representatives of the qualified bidders. The Committee verified the offers made by the firms and reported that the below mentioned offer of M/s. Chipsan Aviation Private Limited, Vasant Vihar, New Delhi was the lowest one. The State Police Chief, vide letter read as 6th paper

above, recommended the reports of the Technical Committee and the Financial Bid Opening Committee with a request to accept the same after verification of reports and to issue orders in this regard .

4) After having examined the report together with the requisite documents in detail, Government directed the State Police Chief to carry out negotiation with M/s. Chipsan Aviation Private Limited for reducing the cost and escalating the service hours. The State Police Chief, vide letter read as 7th paper above, reported that considering the demand made during negotiation, the firm was willing to increase the hours of flying by five (5) hours, i.e, 25 hours of flying in total, non-cumulative in the same rate quoted in the tender (Rs.80,00,000). The State Police Chief also reported that the helipad and hangar facility of M/s Chipsan Aviation Private Limited at Chalakudy could be made use of at a minimum rate, for parking the helicopter and requested to accord sanction to proceed with the proposal of M/s. Chipsan Aviation Private Limited.

5) Government have examined the matter in detail and are pleased to accord sanction to proceed with procurement of the service of helicopter from M/s. Chipsan Aviation Private Limited on wet lease basis for various operational purposes for a period of 3 (three) years from the date of signing of agreement/positioning of helicopter, whichever is earlier, with provision for extension for 2 (two) years at the same rates

of fixed monthly charges and flying hours as specified below:-

6) The General Plan for utilization of the fixed monthly hours of the helicopter service, proposed by the State Police Chief as per letter read as 8th paper above, is also sanctioned as follows:-

7) The State Police Chief is also permitted to alter the time plan as per specific requirements during emergent situations.
